State Deputy's Message—Recruiting Tools

In the past couple of months we've stood up another Spanish-language Admission Degree team and a new Spanish-language Formation and Knighthood Degree teams. We plan on keeping these men busy and if we do so, it will be a wonderful thing.

Have you ever been to a Spanish-language Mass at Sts Peter and Paul, Our Lady of Guadalupe, Sacred Heart, or Our Lady of Lourdes in Magna? If you want an eye-opening experience, go. What you will see is a full church and more. At Sts Peter and Paul not only is the church full, but so is the hall, with a TV showing the Mass that is being celebrated 50 feet away. At Our Lady of Guadalupe the hallways are also full, full of people sitting if they are lucky, kneeling when they have to, and fathers holding their young children. At Sacred Heart, the hall is directly under the church and both are full to overflowing, to the point that the stairwell leading downstairs is full too. At Our Lady of Lourdes, for the English-language masses the church proper is mostly full. For the Spanish-language masses, a sliding door is opened and not only is the church full, but the hall next door is also very full. Our mission churches, like St. Lawrence in Heber City experience the same crowds.

It is the men who attend these masses who we want to, need to, attract. They stand up for the entire Mass, often holding a child the entire time. Look around your council, how many men do you have that would do that? Many of these men work multiple jobs to support their families. These men demonstrate what it means to be Knights without being members. They are faithful Catholics. They are dedicated family men. They are hard workers.

Some accommodations might need to be made. Did we make accommodations when we got married? Did we make accommodations when we were raising our children? We all did. Are we better off because we did? Certainly. These new Knights might need some additional hand holding, perhaps a translator at your meetings. Their schedules could be a little different than your existing Knights, but that is to be expected with their differing schedules. But, make them feel welcome and you, your council, and your parish will gain a treasure.

By being welcoming to Spanish-speaking men, we have councils that have shown tremendous growth in numbers, and with it the inevitable growth in charity and good works for the church by their new members. Some might have issues paying dues. I know when I was Grand Knight, I would have gladly taken 10 men who worked hard and not paid dues. One breakfast or a portion of a bingo could easily cover their dues and look at the ongoing reward you and the church will receive.

Attend a Spanish-language Mass some time. It is not only eye-opening but very interesting as well to see the Mass you are used to in a different language. There are also masses held in Latin, Vietnamese, Tagalog, and Polish, and other languages around the state. I think doing this might help you see, appreciate, and love our Mass even more. You will also better understand the universality of our faith and our order, a fraternity that spans cultures and languages because of what we share; faith, family, and fraternity.

State Secretary's Corner

Preparing for the Upcoming Elections

First, the guidelines from Supreme. Section 128 of the Laws of the Order states that officers are to be elected by ballot at a regular business meeting held starting May 1st up to and including June 15th. Immediately after the election of officers, the financial secretary should report the officers-elect to the Supreme Council using the Member Management Application located in Officers Online on the Knights of Columbus web site or by using the Report of Officers Chosen for the Term (#185) which is available at KofC.org/forms. Also, the candidate must have completed his 3rd (Knighthood) degree exemplification before taking office.

A quick refresher on the council offices to be filled. The elected officers are the Grand Knight, Deputy Grand Knight, Chancellor, Recorder, Treasurer, Advocate, Warden, Guards, and Trustees. The appointed positions are Chaplain, Financial Secretary, and Lecturer. The detailed assignments and job description of each office can be found at KofC.org in the Leadership Resources document, duties of Council officers section. For additional information, refer to the Duties and Responsibilities of Council Officers and Directors (#4241).

Depending on the particular position of the Knight who could be nominated to fill the various council positions, here's 10 questions to ask when considering council officers;

- 1. Are they committed to the mission of the council?
- 2. Do they demonstrate ethical character?
- 3. Do they communicate effectively?
- 4. Do they have a teachable heart?
- 5. Are they flexible?
- 6. Are they team oriented?
- 7. Do they lead by example?
- 8. Do they demonstrate accountability?
- 9. Do they have influence within the membership?
- 10. Do they have a heart to serve?

We all have various backgrounds and life experiences, and fulfilling all the above considerations would be difficult at best. However, it's never too early to begin seeking candidates to replace those who will be completing their assignments or changing roles within your council. Helping your council spot potential candidates now and discussing role(s) with them will give them time to consider the roles offered. Best wishes as your council undertakes the process of electing next year's officers.

Connecticut Catholics Raise Awareness of the Plight of Middle East Christians

ARCHDIOCESE AND KNIGHTS OF COLUMBUS PARTNER TO ASSIST TOWNS DEVASTATED BY ISIS

NEW HAVEN, Conn. – Connecticut Catholics – including high school students – are coming to the aid of persecuted Christians and other religious minorities in the Middle East in partnership with the Knights of Columbus. This work was highlighted Sunday at a special Mass in New Haven offered by Archbishop Leonard Blair.

The effort by the Archdiocese of Hartford has included the participation of Catholic students selling olive wood "solidarity crosses" made in the Middle East and supplied by the Knights. The money raised will be will be used to help assist Christian towns in Iraq and Syria that were devastated by ISIS and fighting involving the terrorist group.

"We are very grateful to the Archdiocese of Hartford for its support of those who have been persecuted for their faith in the Middle East, and we have been truly inspired by these high school students who have taken time and energy to learn about this important issue and raise money to help," said Knights of Columbus CEO Carl Anderson. "We hope this program will be the first of many of across the U.S. and Canada."

All nine high schools in the archdiocese have made efforts to familiarize students with the genocide of Christians in the Middle East and have each adopted a "Sister Town" in the region to keep in their prayers.

Sunday's Mass was held at St. Mary's Church in New Haven. The Chaldean Catholic Bishop of Canada Bawai Soro was the homilist and also proclaimed the gospel in Aramaic, the language spoken by Jesus. Bishop Soro is a native of Iraq who has ministered for many years to the Iraqi Christian community in North America.

The inner form of Christian familial love is mercy like God the Father who is "rich in mercy" (Eph 2:4).

Meditation

From Pope Francis' Amoris Laetitia

Once we allow ill will to take root in our hearts, it leads to deep resentment, ... The opposite of resentment is forgiveness, which is rooted in a positive attitude that seeks to understand other people's weaknesses and to excuse them. As Jesus said, "Father, forgive them; for they know not what they do" (Lk 23:34). Yet we keep looking for more and more faults, imagining greater evils, presuming all kinds of bad intentions, and so resentment grows and deepens. ... Something is wrong when we see every problem as equally serious; in this way, we risk being unduly harsh with the failings of others. The just desire to see our rights respected turns into a thirst for vengeance rather than a reasoned defense of our dignity.

When we have been offended or let down, forgiveness is possible and desirable, but no one can say that it is easy. ... All this assumes that we ourselves have had the experience of being forgiven by God, justified by his grace and not by our own merits. We have known a love that is prior to any of our own efforts, a love that constantly opens doors, promotes and encourages. If we accept that God's love is unconditional, that the Father's love cannot be bought or sold. then we will become capable of showing boundless love and forgiving others even if they have wronged us. Otherwise, our family life will no longer be a place of understanding, support and encouragement, but rather one of constant tension and mutual criticism.

Considering that Jesus forgave his persecutors from the cross, what does God's mercy in the scriptures teach us about how to forgive our family members?

Why is it important to be forgiven by God? Why must we trust in his forgiveness in order to forgive others properly?

Do any of us find it hard to forgive? What holds us back from forgiving? Is it resentment based on ill will, unduly looking for faults, an excessive concern for our rights, the inability to forgive ourselves or to accept our own limitations? Or is it something else?

Membership Memo—The Gift of Membership

How do you eat an elephant? One bite at a time. Since becoming a state officer and the state membership director I have gained a new perspective in regards to membership growth. At the council level and when I was Grand Knight I knew membership growth was important for the council but didn't think about the big picture or membership for the state. I just focused on what I was doing and my local council and the needs of the state or the entire order for that matter weren't as important to me. I'm not suggesting not focusing on the local level, in fact just the opposite. Knowing that the local council membership growth is what makes up the big picture, this is the one bite at a time. I encourage all the councils to look at the big picture and realize where they fit in. It is vital for every council to grow so that we as a state and the entire order will be successful and the Knights will continue doing good works and helping the church and men be better. Achieving the goal of our membership growth for the state can feel unattainable, the elephant. But when you break it down one bite at a time it is very attainable if we all do our part and know we at times may have to do more to make up for others.

In some ways, at the council level achieving the membership goal can feel like an elephant. I just heard from the Grand Knight at St Thomas More about how they recruited one guy from RCIA, one from a fish fry, and another from a personal contact he had. This is the one bite at a time approach and is what is needed. Again, I encourage all councils to take this approach, everything you do is a recruiting opportunity and if it is done throughout the year one bite at a time you will attain your goal.

We are now in the home stretch of the fraternal year and we still have a way to go to achieve our goal, please do all that you can in these last two months. I have talked with several Grand Knights and councils over the last couple of years and many wait for a church drive to recruit or wait for something else stating this is how they do it. The something else or time is now to get those men in, the wait is over and we need them. But also the time is now to start changing "how we do it," look at next year and start planning your one bite at a time approach for the future of your council, our state, and our order. All information submitted is maintained in strict confidence. Knights of Columbus prohibits retaliation against those who have direct or indirect knowledge of or have reasonable cause to suspect abuse or misconduct against a minor and who make a good faith report of such abuse or misconduct.

Insurance Assurance—Disability Insurance Awareness Month

Not only does the month of May host many important holidays including Mother's Day and Memorial Day, but it is also Disability Insurance Awareness Month. - 2. The average group long-term disability claim lasts 34.6 months.
- 3. The average individual disability claim lasts 31.6 months.
- 4. Medical problems contributed to 62% of all personal bankruptcies filed in the U.S.
- 5. About 1 in 4 of today's 20 year-olds will become disabled before they retire.
- 6. One in 8 workers will become disabled for five years or more during their lifetime.
- 7. Over 37 million Americans are classified as disabled; about 12% of the total population.
- 8. As of 2013, 8.8 million Americans were disabled.
- 9. Around 64% of Americans believe their chances of becoming disabled are much lower than the actual odds.
- 10. Almost all disabilities (90%) are caused by illness, not accidents.

Bishop Soro explained that the Christians of Iraq would not have survived the past four years without the help of fellow Christians from around the world.

"The message that I have for the Knights of Columbus is one of admiration, that you are amazing. We thank you," the bishop said. "We are encouraged by your model, please continue. I know many of the good things that have been done have been influencing us and I know that what you see publicly is only 10 percent of the things that the Knights have been doing. We pray that this will continue and God bless you all."

The Mass was followed by a reception and a question-and-answer session that included Stephen Rasche, counsel to the Chaldean Catholic Archdiocese in Erbil, Iraq, Archbishop Blair and Bishop Soro, and Andrew Walther, vice president for communications and strategic planning for the Knights of Columbus.

"Our mission is to preserve the word and example of Christ in the Middle East, and this we are committed to do, whatever the cost," said Rasche. "In this, we are grateful for the support and solidarity we have received from our brothers and sisters in CT and elsewhere."

As part of its advocacy on behalf of persecuted religious minorities in Iraq, Syria and the surrounding region, the Knights led a major campaign urging the U.S. Congress and the U.S. Department of State to declare ISIS' terrorism an act of genocide. To support the cause, it produced a nearly 300-page report on ISIS' atrocities against Christians that was used by the department to support its 2016 finding that a genocide was, indeed, taking place.

In addition, the K. of C. has urged the U.S. government to ensure that communities targeted for genocide not be overlooked in its aid programs and applauded Vice President Mike Pence's announcement last fall that the Trump administration would begin providing aid directly to religious minorities impacted by ISIS' genocide.

Columbian Award "Featured Programs"

Church—

REFUND SUPPORT VOCATIONS PROGRAM (RSVP)

RSVP allows councils and assemblies to "adopt" one or more seminarians or postulants and provide them with financial assistance and moral support.

The intent of RSVP is to demonstrate support for individual seminarians. RSVP support is not solely financial aid, and councils are asked not to base their support on the financial needs of the seminarian. All seminarians are worthy of support through RSVP by virtue of the fact that they are discerning a religious vocation, not because of their financial situation.

Please remember that with RSVP, Knights provide more than financial support; members write letters to the seminarians or postulants, sponsor dinners for them, invite them to join the council and, most importantly, pray for vocations.

Participating councils and assemblies receive a \$100 refund for every \$500 donated to an individual. The maximum refund a council or assembly can receive is \$400 per individual supported per year.

Community-

GLOBAL WHEELCHAIR MISSION

For every donation of \$150 received by the Global Wheelchair Mission, it can deliver a brand new wheelchair which would cost over \$500 in a medical supply store.

They are shipped in containers of 100 to 280 wheelchairs each directly from the factory to the destination countries at no cost to the recipients.

Report your activities to the Supreme Council with the Global Wheelchair Report (#10071) or for Canadian councils the Global Wheelchair Report (#10071-C).

If the council, working with the parish, raises the funds to purchase 100 or more wheelchairs, the council would fulfill all four of the programming requirements in the Community Activities category for the Columbian Award.

Supreme and State Recruiting Incentives

Star Council Award

Prior to the end of the fraternal year on June 30, make sure that your council achieves the requirements to qualify for the Father McGivney, Founders', Columbian and Star Council Awards. There are no application forms for the Father McGivney and Founder's Awards.

Columbian Award

This award recognizes excellence in your council's programming and charitable outreach. Complete and submit the Columbian Award Application (#SP-7). Councils must conduct and report at least four major programs in each of the Service Program categories: Church, Community, Council, Family, Culture of Life, and Youth. Completed applications must reach the Supreme Council office by June 30.

In addition to meeting the traditional Columbian Award requirements – conducting at least four programs in each category – each of the six Columbian Award categories also has at least one featured program. By meeting all requirements for a featured program activity in a particular category, a council fulfills all requirements for that category. The six categories and the featured programs for each are as follows:

Church – Refund Supports Vocation Program (RSVP) Community – Habitat for Humanity, Global Wheelchair Mission Council – Special Olympics Culture of Life – Ultrasound Initiative, March for Life Family – Food for Families Youth – Coats for Kids Founders Award

Father McGivney Award

This award recognizes excellence in your council's membership growth. Your council must meet or exceed its yearly membership quota to be eligible. The quota for councils is 7 percent increase of the council's membership as of July 1. The minimum quota is 4 and the maximum is 35. Councils that attain Star Council status and achieve 200 percent of their net gain goal will receive the Double Star Council Award. If they achieve 300 percent of their net gain goal, they will receive the Triple Star Council Award.

Founders' Award

This award recognizes excellence in your council's promotion of our top-rated and exclusive insurance products. Your council must meet or exceed its yearly insurance quota to be eligible. The quota for councils is a 2.5 percent net increase in insurance membership as of July 1 for the fraternal year. The minimum quota is 3 and the maximum is 18.

(Note: all membership and insurance transactions must be received, processed, recorded and released at the Supreme Council office by June 30.)

HBITAT FOR HUMANITY

Habitat for Humanity is a nonprofit, Christian organization founded in 1976 that seeks to eliminate poverty housing and homelessness one family at a time. The organization assists in providing quality-built, affordable homes to needy families by cooperatively involving the future homeowner with community volunteers and suppliers to build or renovate the home. To date, Habitat for Humanity has provided more than 6.8 million people with safe, personal shelters by completing over 800,000 houses in more than 100 countries with a goal of a million homes around the world.

If your council or assembly donates both \$1,000 and 200 man hours to Habitat for Humanity, it will fulfill all four requirements for the community activities category of the Columbian Award (SP-7).

Council—

SPECIAL OLYMPICS

The Knights of Columbus believe that the Special Olympics are nearly unparalleled in their ability to show the intrinsic worth and dignity of every single human being. These games don't just build strength and character in the athletes and participants; it only takes a few moments with the competitors to be inspired by the force of their determination, and the true sense of God's love.

Although the Special Olympics have grown in recent years, they still need our continued support. We encourage chapters and parishes around the world to organize fundraisers, events, and donation drives that will continue to benefit this magnificent event. The Special Olympics are too wonderful to overlook, and the Knights of Columbus are committed to bringing the games to all corners of the globe.

If your council or assembly raises \$2,000 and contributes 200 man hours, your council would fulfill all four requirements for the Columbian Award in the Council Activities category

Culture of Life-

ULTRASOUND INITIATIVE

Through the Ultrasound Initiative, when a state or local council raises 50% of the cost of an ultrasound machine, the Supreme Council will provide the other 50% of the cost to complete funding for purchase of an ultrasound machine that will help a PCC to provide for the health of mothers and their unborn children.

Councils or Assemblies that raise 50% of the cost of an ultrasound machine would fulfill all four requirements for the Columbian Award in the Culture of Life Activities category

MARCH FOR LIFE

The annual March for Life, held on or around January 22 in Washington, D.C., commemorates the anniversary of the U.S. Supreme Court's infamous Roe v. Wade decision that legalized abortion on Jan. 22, 1973. This year, the March for Life will be held on Friday, January 19, with the theme, "Love Saves Lives." All Knights and their families, particularly those in the greater Washington, D.C., area and nearby states, are urged to join the march. Councils planning bus trips to Washington should book their charters early. Knights should carry council banners and K of C posters, wear jackets with the K of C emblem, and walk together to show the Order's support for the right to life.

Knights who cannot go to Washington can participate in local or state pro-life demonstrations. State pro-life chaircouples will have information on local activities sponsored or supported by Knights in their jurisdictions.

Councils or Assemblies meeting minimum participation requirements will fulfill all four activity requirements in this category

Family-

FOOD FOR FAMILIES

The Knights of Columbus is committed to ending hunger in local communities by asking local councils to participate in the Orderwide Food for Families Program.

To encourage local Knights of Columbus councils to participate in this worthwhile program, the Supreme Council offers financial rebates to councils and assemblies that donate food or money. For councils or assemblies, the Supreme Council will refund \$100 for every \$500 donated, or for every 1,000 pounds of food that a council contributes to a parish food pantry, community food bank or soup kitchen - up to a maximum of \$500 per council/ assembly per fraternal year. Reported contributions of food and/or monetary donations should be cumulative for the fraternal year and there is no need to send in a refund request every time a contribution is made. However, to be eligible for the rebate, the cumulative total of contributions of food/ money needs to reach a minimum of \$500 or 1,000 pounds of food for councils or assemblies.

In addition, the Supreme Council recognizes that participating in this program can be time consuming for the local council. Should a council choose to participate in this program, this will fulfill all four of the Family Activity requirements for the Columbian Award.

In order to qualify as fulfilling all four requirements, the council must collect and donate a minimum of 1,000 pounds of food and council members must contribute a minimum of 100 man-hours in the program.

Youth—

COATS FOR KIDS

Through our Coats for Kids program, 1,780 local councils distributed 87,906 coats to children in need throughout the United States and Canada in 2016. Since the program began in 2009, nearly 400,000 coats have been distributed.

Councils or Assemblies meeting minimum participation requirements will fulfill all four activity requirements in this category

- Church The featured program is the Refund Supports Vocation Program (RSVP).
- Community There are two featured programs, Habitat for Humanity and the Global Wheelchair Mission.
- Council The featured program is Special Olympics.
- Culture of Life A council can satisfy all requirements for the Culture of Life Activities category by participating in either the Knights of Columbus Ultrasound Initiative or a local, regional or national March for Life.
- Family The featured program is the Knights of Columbus Food for Families program.
- Youth Participating in the Knights of Columbus Coats for Kids program meets all requirements in the Youth Activities category.

PROGRAM SPOTLIGHT – Star Council Award. Ensure that your council is on track to earn the Star Council Award. Check the status of your council's progress toward earning the Father McGivney Award (membership), the Founder's Award (insurance) and the Columbian Award (programs) using the Form SP-7 Application due June 30 https://www.kofc.org/en/forms/ council/columbian_awardap_p.pdf.
