## Flag Day, June 14th

Did you know? The Flag that withstood enemy bombardment at Fort McHenry, Maryland on September 13th & 14th, 1814, which inspired Francis Scott Key to write "The Star Spangled Banner", actually had 15 stripes and 15 stars? It was not until April 4th, 1818 that Congress passed a law stating that the national flag hold 13 stripes to represent the original colonies and requires that a star be added for each new state on the 4th of July after its admission.

When commemorating Flag Day, remember; it is the universal custom to display the flag from sunrise to sunset. However, when a patriotic effect is desired for special occasions, the flag may be displayed twenty-four hours a day if properly illuminated during the hours of darkness.

# State Secretary's Corner

## Preparing for the new fraternal year

As we prepare for elections and plans to start the new fraternal year, here's a couple reminders to ensure those returning officers and those newly elected start with a common understanding and expectations. First, duties of council officers as outlined in Leadership Resources. For additional information, refer to the Duties and Responsibilities of Council Officers and Directors (#4241).

Chaplain - Serves as spiritual advisor to the brother Knights and families of your council.

**Grand Knight** - Presides over all meetings and appoints program and membership directors and committees as needed.

**Deputy Grand Knight** - Assists the grand knight with operation of the council and any other duties assigned to him by the grand knight, and recommended to serve on the council's Retention Committee.

**Chancellor -** Has the duty of strengthening the members' interest in council activities, and recommended to serve on the council's Admission Committee.

**Financial Secretary** - Upon recommendation of the grand knight and the trustees, the financial secretary is appointed for a three-year term that is approved by the supreme knight. The prospective financial secretary must also complete and submit the Application for Appointment as Financial Secretary (#FS101).

**Recorder** - Responsible for keeping and maintaining a true and permanent record of all actions of the council and maintains all correspondence of the council.

**Treasurer** - Charged with handling council funds, receives money from financial secretary and deposits it in the proper council accounts, and responsible for paying all council expenses including assessments from the Supreme Council.

**Advocate -** Acts as parliamentarian for the council. Should have a working knowledge of Robert's Rules of Order, Charter, Constitution & Laws, council by-laws, and Method of Conducting Council Meetings (#10318). When needed, will seek legal assistance from the state advocate.

**Warden** - Responsible for supervising and maintaining all council property and sets up council chambers for meetings and degree exemplifications.

**Inside/Outside Guards -** Attend the doors of the council chamber and checks for current membership cards and allowing entrance.

**Board of Trustees -** Consists of grand knight and three other elected members and supervises all financial business of the council and conducts the semiannual audits. Trustees are elected for terms of three years, two years and one year.

**Lecturer** - Appointed by the grand knight and responsible for providing suitable educational and entertaining programs under the "Good of the Order" section of council meetings.

Second, meet with your Pastor. Council officers and program personnel should meet with your Pastor to create a plan to determine which Domestic Church programs the council will be able to sponsor. Also, discuss this plan with your Pastor to see how the council's programs can be incorporated into the existing parish framework. You can use the following ideas and points when preparing for the meeting:

- 1. What are the top parish priorities over the next few years? How can your council lead or support those initiatives?
- 2. What is your council already doing that your pastor and parish would like you to continue or expand in support of parish families?
- 3. Be open to new ideas and opportunities that your pastor may have for your council. If other parish groups are already taking the lead on similar programs, your council should be prepared to collaborate and support their efforts.
- 4. How can the council be a vehicle for the men of your parish to grow in their faith and support and nurture the Catholic faith within their families?
- 5. Bring a copy of The Family Fully Alive (#10162) program book to the meeting for discussion. Consider the possibility of providing this book to every council family.
- 6. Could the Family Fully Alive monthly program be incorporated into the parish's ministry to families? How can the Knights of Columbus help to facilitate this experience?
- 7. Make plans to have regularly scheduled conversations between the pastor and council leadership to both assess current initiatives and discuss new programs or new approaches to existing programs.

I hope the above information will help you plan for a successful year and wishing you all a smooth transition.

#### Warriors to Lourdes

U.S. "WOUNDED WARRIORS" JOINING THOUSANDS OF INTERNATIONAL MILITARY PILGRIMS IN LOURDES

NEW HAVEN, CONN. — More than 200 active and retired U.S. military personnel will take part in the annual Warriors to Lourdes spiritual journey dedicated to individual healing and a more peaceful world. The May 15-22 journey is timed to coincide with the 60th annual International Military Pilgrimage (PMI).

"The Marian Shrine at Lourdes is a place of hope where healings of many types take place, both physical and spiritual," said Knights of Columbus CEO Carl Anderson. "It is an opportunity for active-duty personnel, veterans and their caregivers to experience an abundance of peace and consolation while in this holy place."

The visit to Lourdes is organized by the Archdiocese for the Military Services, USA (AMS) and supported by the Knights of Columbus. The PMI will draw tens of thousands of troops, veterans, and others from around the world to the famous shrine to the Blessed Virgin Mary. The theme for this year's PMI is Pacem in Terris(Peace on Earth).

In a message to participants on behalf of the military archdiocese, His Excellency, the Most Reverend Timothy P. Broglio, J.C.D., thanked Anderson and the Knights "who have so generously made possible the pilgrimage of many wounded warriors and infirm veterans who would not otherwise have been able to join in this important international prayer for peace."

Archbishop Broglio urged the pilgrims to pray "for progress in international dialogue, welcome for the immigrant, and a decrease in violence in our communities and the world."

The PMI will include an international opening ceremony and events with the color guards of many countries in attendance. The pilgrims will also have daily Mass, times of reflection and reconciliation and have the opportunity to bathe in the waters of Lourdes from which many seek spiritual, physical or emotional healing.

Support for the pilgrimage by Knights of Columbus Charities, Inc., follows on a long history of the organization's support for military troops and veterans.

This year marks the 100th anniversary of the conclusion of World War I. During that conflict, the Knights of Columbus established a system of "Army Huts" in America and Europe that provided social, recreational and spiritual resources for Allied servicemen, with the motto "Everybody Welcome. Everything Free."

The PMI was inaugurated following World War II to foster "reconciliation, peace and healing" and has grown to become a prayerful and festive occasion. In addition to the military and religious pageantry of Lourdes, pilgrims also have the opportunity to meet service men and women and veterans from around the world — many attired in colorful dress uniforms.

#### About the Archdiocese for the Military Services, USA (AMS)

The AMS was established as an independent archdiocese by Pope Saint John Paul II in 1985 as the only Catholic jurisdiction responsible for endorsing and granting faculties for priests to serve as chaplains in the U.S. military and VA Medical Centers.

AMS-endorsed priests serve at more than 220 U.S. military installations in 29 countries, making the AMS the nation's only global archdiocese. AMS-endorsed chaplains also serve at 153 VA Medical Centers throughout the U.S.

The AMS service population also includes American Catholic civilians working for the federal government in 134 countries, but currently, due to limited resources, the AMS cannot adequately serve this population.

Worldwide, an estimated 1.8 million Catholics depend on the AMS to meet their spiritual and sacramental needs.

Imagine you're trying to fill a bucket with water. Every drop you put in should increase it's contents, but if there's a leak then you may end up losing more water than you gain. If members ask themselves "Why am I here?" then something is wrong with the way your council is conducting its meetings. Follow these guidelines for well -run meetings:

- Keep council meetings interesting • and relevant.
- Start meetings on time and keep discussions, comments, etc. within reasonable limits.
- The grand knight should refer any nonessential matters to the appropriate committees.
- Hold meetings on a night . convenient to most members.
- Allow all members to voice their opinions in an orderly way and try to keep meetings open and relaxed.

## KEEPING MEMBERS INTERESTED

The key to success in any council is keeping members interested, excited and active. One way you can do this is by encouraging members to participate fully in council activities.

Here are some of the ways to show interest in new and established members alike and to help them become active participants in the council:

- Telephone members and remind them of meetings.
- Offer to provide transportation to members who would like to attend council functions, but don't have the means to get there.
- Answer questions. Members will ask why council activities are done in a certain way and if things can be changed. Provide them with sufficient information.
- Inquire about the particular interests of the members through membership surveys.
- Help new members make new friends in the council by introducing

## STATEMENT OF THE KNIGHTS OF COLUMBUS ON THE TRUMP ADMINISTRATION'S CHANGE IN TITLE X FUNDING FOR ABORTION

#### 5/18/2018

"Today marks an important step in protecting the lives of unborn children in the United States. The Knights of Columbus applauds the Trump administration's announcement that it intends to end the use of Title X taxpayer funding for centers that perform, support or refer abortions.

Americans should not be forced to have their tax dollars fund abortion. In fact, Knights of Columbus Marist polling conducted earlier this year found that most Americans believe abortion is morally wrong and six in 10 want an end to its funding with tax dollars.

There is a consensus that crosses party lines. Of those polled, four in 10 who identify as pro-choice and more than four in 10 Democrats-along with the overwhelming majority of Republicanswant to see an end to taxpayer funding of abortion."

More than three quarters of Americans would limit abortion to - at most - the first three months of pregnancy, according to a new Marist Poll. That number has consistently been about three quarters or more for the past decade.

This year, the survey found that 76 percent of Americans want such limits. Strong majorities of Republicans (92 percent), Independents (78 percent) and Democrats (61 percent) agree, as do a majority of those who identify as prochoice (60 percent).

While a slim majority of Americans (51 percent) identify as pro-choice, even 60 percent of those who identify as such also support substantial limits.

On specific policy issues, the poll also found that more than 6 in 10 Americans (63 percent) would ban abortion after 20 weeks of pregnancy, while a similar number oppose using tax dollars to pay for abortion (60 percent).

them to all fellow Knights.

- Be aware of personality conflicts and try to avoid them as much as possible.
- Do all you can to help members feel important to the council.
- Get members' names in the council's newsletter, both when they join and as they begin to take an active role.
- Be sure members' names are always spelled correctly, whether in the membership directory, on a name tag at a meeting or in a news story.

Establishing caring and concerned relationships among council membership will encourage your members to participate in council activities. By showing interest in new and old members alike, your council will confirm its commitment to members and will increase their willingness to assist in programs.

#### FRATERNAL – FIRST AND FOREMOST

Throughout history, fraternal societies have grown and flourished for many reasons. Some promoted social integration for their members, others provided economic security to members and their families through the sale of insurance. Some of these fraternal societies came into existence to strengthen common ties of a religion among their members while others served to give social status to their members.

The Knights of Columbus was founded by Father Michael J. McGivney as a society to promote fraternity among Catholic men. That fraternity – the sense of brotherhood among members and the families of members – remains, along with its Catholicity, the defining characteristic of the Order's identity.

To maintain a strong, friendly and fraternal atmosphere among Knights and their families, councils should conduct programs that build camaraderie and pride in membership. These fraternal programs don't have to be complex.

Do not let your hard recruitment work go to waste by focusing on retention as much as recruitment.

- 5. Were families involved to a sufficient degree? If not, how can family involvement be expanded? 6. Were the entire parish and community involved in these efforts?
- 6. Were Supreme Council materials fully utilized?
- 7. What programs can be expanded or improved? How can glitches be avoided next year?
- 8. How might your council plan differently or more wisely in the upcoming fraternal year?

Please share this year-end inventory and evaluation with your council's incoming grand knight and program directors.
