State Update

State Deputy's Message—Preparing for a New Year

Plans for starting the new fraternal year have been progressing at a rapid pace since the State Convention held in early May. The State Officers Team has been preparing to take on their new positions with enthusiasm and dedication. The Organization Meeting, to be held on 7 July at St James the Just, will provide us the first opportunity to gather together as the state council to review plans and share ideas to ensure we have a successful year.

I recently had the privilege of attending the State Deputy Organization Meeting in New Haven, CT. I was one of 76 first and second year state deputies in attendance from the United States, Canada, Poland, Mexico, Philippines and the Dominican Republic. It was a most memorable experience meeting all the super people at Supreme, visiting the headquarters, and being installed as State Deputy in St Mary's church. Passing by Fr. McGivney's resting place was a humbling and inspirational experience.

Let me give you a sneak preview of what's ahead for the upcoming year. Regarding membership recruitment, the new Faith in Action model (enhanced Building the Domestic Church initiative) will give us the framework and tools to build better councils and recruit men to our mission. To appeal to younger men and their families, we must promote faith-based and family events. Also, promote leadership appointments of younger men.

Another new initiative is Online Membership. Online membership can help us boost our intake by 10-20%. We can also help enrich the online members' experiences by sharing our events and news stories on Knights.net.

Hispanic and ethnic growth have great opportunities here in Utah. Rafael Castillo is our state Hispanic Outreach Coordinator, and he has already started visiting councils and making plans. While at Supreme, I solicited the assistance of Marty Yzaguirre, Supreme Hispanic Outreach, and he agreed to help us as necessary with recruiting opportunities.

Membership retention efforts start the day they take their Admission degree. Take the effort to make retention personal. Understand what members want to get out of their membership, and give them every opportunity to get what they want. Also, build and work your best practice process regarding "unpaid dues" members you want to write off. The state has a process you must follow to ensure these men were afforded every opportunity to reestablish their good standing.

Programs, centered on the Faith in Action Model, are key to encouraging current and potential members to stay engaged with council activities. We must adopt and implement this initiative. We must be the catalyst for change. We must be able to explain how it will help our councils, our members and our parish and ultimately help our recruitment efforts. New and updated resources are forthcoming and will be available in late July, or sooner.

Lastly, training courses and Webinars provide useful tools to help us be successful. Encourage and promote participation in Webinars and Training Portal courses. Set a good example by endorsing and attending Fraternal Training Webinars. There is a direct correlation between high participation and high performing councils. By using the Fraternal Leader Success Planner, your ability to plan ahead then track and measure success on a monthly basis will become a most useful tool.

Bottom line, we must embrace change and lead that change in our state. We must also encourage local parish and community involvement with our programs. Finally, always be mindful that every program represents a recruiting opportunity.

State Secretary's Corner

Forms, forms, forms!!!

It's that time of year when your Form 185 (Report of Officers Chosen for Term) and Form 365 (Service Program Personnel Report) are due. Last fraternal year we had 5 councils never submit their Chosen Officer Report (185) and 10 councils never submit their Service Program Personnel Report (365). Not only are these a requirement to enter but they are invaluable so Supreme and the State knows who to contact at your council and for the state directory. Also, some of the forms or information are required to achieve Star Council.

If you never submit your Form 185 (Officers) how will Supreme know who to give access to Officer's Online and member management? These are amazing tools that I feel are being underutilized and can help you know what's going on with your council or to get contact info for your members.

So who's responsibility is it to fill out these forms? The Grand Knight, the Grand Knight is the leader of the council and ultimately is responsible for the council. He can have the Financial Secretary do it or assist or even delegate this responsibility but he needs to make sure it is done and the forms are submitted.

In the following months, I will be working on compiling the State Directory and can't do that if I don't get your forms. Both of these forms (185 and 365) can now be filled out online through member management, if you need assistance with doing these please reach out to me or your District Deputy for assistance. My goal is to have the directory out to you earlier than it has been in the past.

In addition to forms, now is the time to plan your year. The Columbian Award application SP7 form will be changing to reflect the new program model "Faith In Action." So I suggest looking into this new model at www.kofc.org/faithinaction and build your calendar around those programs. Most of what you are currently doing will not change, but there are some new requirements for councils. Also, now is the time to put together your budget. The budget should be based on what you are going to do this year, so complete this at the same time or after you have your calendar planned. If you need assistance with these please reach out to any of the State Officers or your District Deputy.

I am so excited for this year and all that we will accomplish and hope you are too! If I can be of service in anyway please let me know.

KNIGHTS OF COLUMBUS CHARITY RISES TO RECENT CHALLENGES

RECORD-SETTING DONATIONS IN '17 KEEP PACE WITH MAJOR NEEDS

NEW HAVEN, Conn. — 2017 was a record-setting year for Knights of Columbus charitable work with an unprecedented \$185.6 million in donations and 75.6 million hours of service provided worldwide.

The monetary value of K of C's service hours is valued at \$1.9 billion based on an estimate by Independent Sector, a network for nonprofit foundations that values a 2017 volunteer hour at \$24.69.

The K of C's 2017 survey of charitable giving also showed that monetary donations increased \$8 million from 2016 (+4.5 percent) and service hours grew by 527,550 (+0.7 percent). Year-over-year annual growth in both categories has been consistent over the past two decades.

"Once again, the Knights of Columbus showed the enormous difference we can make in the lives of others by putting our faith in action," said K of C CEO Carl Anderson. "The needs of many of our communities were

particularly great in 2017, especially in the wake of historic hurricanes in Houston, South Florida, Puerto Rico and much of the Caribbean.

The Knights did not hesitate to provide assistance after these humanitarian crises and in Mexico where two cities were badly damaged by earthquakes."

Since 2014, the Knights' Christian Refugee Relief Fund has donated more than \$17 million for humanitarian assistance to Christians and other religious minorities primarily in Iraq, Syria and the surrounding region.

"Along with what we do in our own communities, the reach of the Knights is global," Anderson said. "We were able to pledge \$2 million to save Karamles, a predominantly Christian town on Iraq's Nineveh Plain liberated from ISIS in 2017. Christian churches and graves were desecrated, and many homes were looted, damaged or destroyed."

K of C Utah

The Knights of Columbus in Utah donated over \$10,000 to the Special Olympics of Utah for the 3rd year in a row, supporting forty athletes for the entire year.
