RE: UPCOMING EXEMPLIFICATION INFORMATION

Dear Knights of Columbus Brothers,

On August 1, 2020 we will hold an Exemplification of the Fourth Degree at St. Francis Xavier Parish, 4420 W. 5215 So., in Kearns, Utah. All candidates are asked to be there no later than 1:00 p.m. and the Degree will begin at 2:00 p.m. In order to achieve the number of candidates we desire at this Degree, (25-30) it is imperative everyone assist in the recruitment of new candidates. Please help get the word out to all Third Degree Knights to invite them to join us. We are inviting everyone to join us. With the degrees not being secret any longer your wife is welcome to observe the degree with you.

**GENERAL INFORMATION:**

- An Exemplification of the Fourth Degree of the Knights of Columbus is the formal initiation into the Degree.
- Every Exemplification is held in honor of a Worthy Sir Knight. The Honoree is named at the banquet and the newly initiated members are presented to him.
- A package with the details of dinner choices and hotel accommodations are sent out in advance in ample time to book before the deadline.
- In order for a candidate to be listed in the Exemplification booklet and have a certificate prepared for them in advance, their name must be given to the Master no less than 14 days before the date of the Degree.
- Last minute candidates can receive the Degree, but they will not be listed in the banquet program; they will not have a certificate prepared for them; and they risk not being seated at the banquet if the event is being catered. Their fee will remain the same. The Exemplification fee will not be discounted for any reason.

**DEADLINE FOR CANDIDATES NAMES IS 14 DAYS BEFORE THE DATE OF THE DEGREE**

- Any member who has received the First, Second & Third Degree prior to the Fourth Degree Exemplification date is eligible provided they are a Third Degree member in good standing.
- The cost of the degree is \$70 which includes one dinner banquet ticket, a social baldric, and lapel pin.
- The event is formal and each candidate and observer is to wear a traditional dark suit, white shirt (lay down collar) tie, with dark shoes (no tennis shoes)
- A dark suit is the new attire for the fourth degree

Please find details for the banquet enclosed. I urge you to promote our Degree work at all levels. Consider hosting a Degree soon in your parish. Have your members attend in preparation for the Fourth Degree. Each Degree is a lesson and this is a most opportune time of year to cover the many areas of Columbianism. I hope to see you on August 1, 2020.
