## State Deputy's Message

Dear Brothers,

Brothers we are now 2 months into this fraternal year... how are you doing? This year is shaping up to be a very interesting year and I think it is very important to continually check in. Check in with yourself and how you are progressing with what you want to accomplish. Check in with the District Deputy and State Officers to let them know how you are doing and if you need anything. Check in with your council member; are they adapting to the "new" way we are doing things, with your meetings, or your programs? I imagine these things have all changed; meetings being virtual or socially distanced, programs are on hold or cancelled and new ways or programs are hopefully being done to accomplish what we need to. How are the members adapting or what are their needs? And lastly, have you checked in with your Pastors?

I asked the District Deputies to check in with each of their councils and make sure we were engaging our Pastors. I stated to them that the goal was to have 100% of our councils engaged with our Pastors by September 1st. Have we done this? I use the word engage because it is more than talking, it's involving them. Involving them with what you and your council is doing and vice versa involving your council with what the Pastor is trying to accomplish or assisting with his and the parish's needs. When engaging with your Pastors keep a few things in mind, the council should be in service to the parish and diocese. Also, communication will help remove misunderstandings. Make sure you are communicating and not assuming the Pastor knows what you want or are doing. If you aren't getting information that you need, don't assume and ask directly for what you need.

Here are some steps and other suggestions on how you can engage or involve your Pastors:

- 1. Request to meet for one purpose, ask how your council may better serve the parish.
- 2. When meeting about a new idea/project address what it will cost the Pastor/parish and if it will create more work for the Pastor. Ideally, it shouldn't cost him anything or create more work.
- 3. Before creating your calendar ask to see the parish's calendar. Explain this is to make the council aware of and assist with important events and to avoid scheduling conflicts.
- 4. Understand the Faith In Action programs before your meeting, ideally targeting programs that will align with what is important to him.
- 5. Ask the Pastor if you or someone from the council can be a part of his "leadership team." This is so you can be engaged with the priorities of the parish and the council can serve them better.
- 6. Be the "rock" or the group the parish can depend on the most. If a Pastor asks for your help, do everything possible to help. This will give your council something to do and will help solidify a positive relationship with your Pastor for years to come.

As I stated at the beginning, I think it is important to continually check in. Check in with your Pastor, your members, and with yourself. Hopefully by now you have used the council goal sheet I shared during the Organizational meeting and shared that with your District Deputy and council members. Check in frequently with that to make sure you are on track with the plan and goals you laid out and with what you want to accomplish.

## Honoring the Legacy of Father McGivney

Over the next few months we'll continue to share additional articles in preparation for his beatification.

### **PASTOR**

In November 1884, Father McGivney was named pastor of St. Thomas Church in Thomaston, a factory town more than 30 miles from New Haven named for the clockmaker Seth Thomas. The parish served working-class parishioners who had few resources beyond their faith. With prayerful acceptance, Father McGivney put his seven years at St. Mary's behind him and moved from the bustling city of New Haven to the smaller town of Thomaston.

At his last Mass at St. Mary's, the large church was filled with grateful souls who felt closer to God through his ministry. A printed testimonial said that his courtesy, kindness and purity of life, despite burdens and afflictions, had "secured



the love and confidence of the people of St. Mary's, which will follow him in every future field of labor." His flock in New Haven was heartbroken at his departure.

In his six years at St. Thomas, Father McGivney was an admirable pastor who built strong ties with parishioners and cared for their spiritual and temporal welfare. He also cared for a mission church, driving his horse and carriage to celebrate Sunday Mass in both locations. He continued to serve as supreme chaplain, but like a true "Father" and pastor of souls, he trusted the leaders of the Order in New Haven to carry on the work he began among them, as the Knights of Columbus continued to grow beyond Connecticut. Having created a thriving parish community, when Father McGivney was transferred from St. Mary's Parish in New Haven to become pastor of St. Thomas Parish in Thomaston, the grief among his parishioners was palpable. A journalist covering his last Mass at St. Mary's described the scene: "Never, it seemed, was a congregation so affected by the parting address of a clergyman as the great audience which filled St. Mary's yesterday. Some of those present wept aloud and others sobbed audibly."

## **HOLY DEATH**



Never robust in health, Father McGivney fell ill with tuberculosis and was stricken with severe pneumonia in January 1890. The young priest lost physical strength just as his Order was moving toward new vitality. After seeking respite and remedies, he was eventually confined to bed in the rectory, where his concern and prayers for his people only increased. He died on August 14, two days past his 38th birthday.

The funeral was an indication of the love and respect the people held for this hard-working, holy parish priest. His funeral drew Catholics from across the state, including the bishop, more than 70 fellow priests, and civic leaders. Mourners rented every available carriage within miles for the procession to the McGivney family plot in Waterbury.

The funeral also reflected the deep personal appeal that Catholics found in the Knights of Columbus. Delegations came from almost every one of the 57 Knights of Columbus councils that had been chartered in the Order's first eight years. Father McGivney's holy example also inspired his two younger brothers, Patrick and John, who followed him into the priesthood and served the Order as supreme chaplains.

Today, the earthly remains of Father McGivney are interred in a polished sarcophagus in New Haven's St. Mary's Church, where he founded the Knights of Columbus. His vision and mission are carried forth by nearly 2 million Knights of Columbus throughout the world, who form a band of brothers under the principles of Charity, Unity, Fraternity and Patriotism.

### KEEPING THE FAITH

Father McGivney not only lived a life devoted to the Catholic faith; he also focused all his spiritual, mental and physical energies on helping others persevere and grow in that faith, and he guarded against whatever might diminish the practice of Catholicism.

For Father McGivney's newly formed Knights, protecting the faith of Catholics was the prime concern, and this quickly took three forms.

First, the Knights would serve as an antidote to those secret societies that lured Catholic men away from their faith by offering financial benefits.



Second, the Order's insurance program would help keep Catholic families together when a breadwinner died; this would also help prevent a loss of faith among widows and orphans forced to live in state institutions or with non-Catholic relatives or adoptive families.

Third, the Knights would champion the full rights of American citizenship for Catholics. This, too, would support the Church, since ensuring equal rights for Catholics would help limit the social or civil pressure on them to abandon their faith.

### PRACTICAL CATHOLICS



The one requirement of membership in the Knights of Columbus is that a man be a "practical Catholic" in union with the Holy See. What does the term "practical Catholic" mean?

Faith for Father McGivney and his Knights was not simply knowing the catechism, important as that is. It was putting into practice the Great Commandment of Jesus: To love God with all your heart and your neighbor as yourself. True to the parable of the Good Samaritan, love of neighbor

does not stop at the church door. It goes out into the streets, the highways and byways, to encounter those on the margins of society – who were often immigrant Catholics in Father McGivney's day – and bring them practical charity and fraternal love.

A "practical Catholic" has a love of home, family and church, where faith is nurtured. Yet his faith leads him into the world, even a world suffused with anti-Catholic sentiment, in the spirit of the Good Samaritan. He is called to bind up the wounds of the sick and abandoned, to provide for their temporal needs, to support the faith of Catholics and pass on the faith to inquirers, and to live a life of prayer and virtue, with love of God and neighbor.

## FAITH IN ACTION

For more than a century, Knights of Columbus have followed the formula of faith put forth by Father McGivney. Today, with a model called Faith in Action, nearly 2 million Knights throughout the world live out the Order's principles of charity, unity and fraternity with programs such as Food for Families, Coats for Kids, Ultrasound Initiative, Special Olympics, Vocations Support, Global Wheelchair Mission, Habitat for Humanity, Consecration to the Holy Family, and days of spiritual reflection.



Thanks to the structure of the Order and the trust that Father McGivney placed in his men from the beginning, there is no limit to the good that a Knight today can do for his family, his parish, his council, and his community as he puts his faith into action.

I sincerely hope that your councils had productive summers; adapting to new ways to conduct business through on line meetings and support of the program Leave no Knight Behind. Last month we saw an increase of 10 new knights in the State. Keep that momentum going so we can attain those goals we set back in June. I hope all council leaders have had a personal sit down with the Pastor to map out new ideas and a path forward as we cope with this Pandemic.



Lastly, take advantage of Jerry Angus's monthly training webinars, it is an hour well spent that will save you both time and frustration as you perform your roles within your councils.

On 23Aug20, I completed and sent out to the leaders group the final draft on the FY20-21 State Directory. I finally received all the officers chosen reports, thanks to those councils who provided timely information. Please take a few moments to review the information, and email me back comments. I want to try to make this as error free as possible. If you have not received a copy, please let me know send me send me a note and I will get out for your review.

Thanks for your submission of the Service Personnel Program Report. These reports support Utah's Safe Environment Program and are necessary to help Brother Frank Carmona track compliance in the state. Supreme should have provided your appointed directors with a login and password. If not, please reach out to Frank and he will work with Supreme to resolve the issue. Reminder, your appointed directors only have 6-8 weeks to complete the 3 training modules, otherwise Supreme will remove them from the position. If this occurs, councils will then be required to refile your Service Report.

Your council's semiannual audit report was due on August 15th. Thanks to the 17 councils who submitted this report so far. Please try to get these submitted within the next month as these are critical to maintain your council's tax-exempt status under Supreme's umbrella per IRS Code Section 501C(8). Also, if any have not filed your Form 990N postcard please take care of that as soon as you can.

Another reminder. If your council plans on conducting the Soccer Challenge and/or the Essay contests this year, I encourage you to order your supplies now since the supply distribution is running behind schedule based on increased demand for materials and many people teleworking at the home office.

Lastly, congratulations to the 30 councils who received Supreme awards from last fraternal year. I sincerely appreciate council cooperation on submission of the SP7 Columbian Award; it was well worth your efforts. Awards included the following: Double Star: 1, Star: 6, Columbian/Founders Award: 8 and Individual Awards: 15.




## **Fourth Quarter Programs:**


## Supreme Chaplain's Monthly Challenge

WHAT IS THE SUPREME CHAPLAIN'S MONTHLY CHALLENGE?

Each month, Archbishop William Lori – Supreme Chaplain of the Knights of Columbus – selects a brief passage from the Gospel reading of one of the Sunday Masses of the month.

Archbishop Lori shares a brief reflection on the passage and

issues a challenge for men to live for the month.



The next month, men undertaking the challenge as a group gather and share their experiences living the challenge.

The Supreme Chaplain's Monthly Challenge is ideally done during monthly Knights of Columbus meetings, but can be done in a separate group or individually.

## This Month's Challenge

September 2020

"For where two or three are gathered together in my name, there am I in the midst of them." (Gospel for Sept 6, Mt 18:20)

There is power in numbers. It's often how we get things done. When men are united by a clear mission, they become a "band of brothers" whose whole is greater than the sum of its parts. And when that mission is given to us by Jesus, we are united in Christ, who directs and strengthens us to accomplish great things. May we, my brothers, form strong bonds of fraternity founded on Christ as we labor to build up the kingdom of heaven.

#### Challenge by Supreme Chaplain Archbishop William E. Lori:

This month, I challenge you to learn more about fraternity by viewing the "Brotherhood" episode of the Into the Breach video series produced by the Knights of Columbus. Second, I challenge you to help build bonds of brotherhood in your parish by offering the Faith in Action Into the Breach program.

#### **Questions for Reflection:**

Are you willing to "stand in the breach" with your brother Knights and fellow Catholics to serve Christ and defend the faith? Are you a good "brother" to others, forming male friendships marked by shared faith, honesty and accountability to fight the spiritual battle? How can a "band of brothers" ensure that they are gathered in the name of Jesus Christ?

## Instructions for the Supreme Chaplain's Monthly Challenge

To conduct the Supreme Chaplain's Monthly Challenge, during a Knights of Columbus meeting (ideally during the Chaplain's Message or the Grand Knight's Report) or other gathering:

1) Open with the Sign of the Cross and perhaps a brief prayer.

Example Opening Prayer: Come Holy Spirit. We thank you for guiding our lives and pray that we may have the courage exemplified by Venerable Fr. McGivney to live our faith to the fullest through our council, our families and in society. May our words today give glory to your Sacred Heart and if we struggled this past month in living our faith, help us to never stop turning to you and always try again.

2) Re-read the Supreme Chaplain's Monthly Challenge from the previous month.

- 3) Open the floor for discussion on what it was like to try and live last month's challenge. Every month has a number of Questions for Reflection that may help facilitate discussion. Don't worry about what order the men speak in or if there is silence in between men speaking. Not everyone has to speak and it is not a problem if the discussion is brief. Men are welcome to comment on others' contribution to the discourse.
- 4) When finished, read the Supreme Chaplain's Monthly Challenge for the next month.
- 5) End by asking if there are any intentions and close with prayer and the Sign of the Cross.

Example Closing Prayer: Heavenly Father, we thank you for this time together with our brothers. We ask you to have mercy on all those people and intentions we prayed for. Give us the perseverance to live next month's challenge and to remember that we are united with our brother Knights around the world in doing so.
