General Information:

An Exemplification of the Patriotic Fourth Degree of the Knights of Columbus is the formal initiation into the Degree. This Exemplification is an afternoon of history about the Knights of Columbus and the Catholic church in the United States.

- Any Third Degree member in good standing is eligible for the Patriotic Fourth Degree.
- A Form 4 (Fourth or Patriotic Degree Membership Application), processed through your Assembly is required for all candidates.
- The cost of the Degree is \$70 made payable to “**KofC Assembly 1429**” upon submission of Form 4 application and mail to Assembly 1429 Faithful Comptroller, Douglas Johndrow, 710 W 2350 No, Layton, UT 84041-4766. The cost includes the ceremony, a social baldric, flag, and a lapel pin, certificate, and banquet for the candidate.
- All candidates are requested to be there on August 26, 2023, no later than 2:00 PM and the Degree will begin promptly at 2:30 PM.
- Deadline for candidates’ names must be submitted to the District Master by **August 19, 2023**.
