

## State Team Reports

## William I. Kelly, State Deputy

Reflecting on this past year, I recognize all of the accomplishments that our State has made to continuing the good works of Blessed McGivney. For without the hard work from our Councils, Knights and Families, these achievements would not have been possible. The rubber meets the road at the council level, and the leadership of officers and programs chairs puts our Faith into Action. I am pleased to report that the Utah Knights will meet or exceed established Supreme goals for this Fraternal Year.

Frank Carmona has done a superb job promoting the growth of the knights this past year. His marketing materials have facilitated Knight awareness in our Parishes and have sustained steady growth month by month. The support of over 40% of our Councils and Parish Priests with local membership drives have enabled Utah to be on the verge of the Circle of Honor award for the second year in a row.

In membership, we started the year with 3123 members and as of April we have 3143. Year to date, we have 145 new members who joined us, well on track to attain the Supreme objective of 170 by fraternal year end. Active membership has decreased from 2670 to 2617 attributable to affiliate transfers of 59 members, and merger of Councils 15741 and 16006 into Council 602. In addition, we had 56 members who passed on to their final resting spot. Please pray for these men and their families.

Eight Councils have met growth goals and have qualified for the McGivney award. 13 councils are on pace to attain the same honor. 31 of 34 Councils have recruited a new member thanks to hard work and perseverance at the council/parish level. We currently have 70 members on the state's online roster, please reach out and invite these men to join your councils. Thanks to exemplification efforts of Bob Masse, 4th degree membership has increased by 40 members. The state has 4 active Round Tables located at St Annes (SLC), St Jude Maronite (SLC), St Lawrence (Heber), and St Christophers' (Kanab). We are optimistic than either St. Anns or St. Lawrence will become councils within the next year or two.

In Nov 2022, we welcomed Bill and Susana Mundy as our Benefits Team to provide service to our 34 councils and membership. Since joining our team, Bill has been on the road continuously with a myriad of appointments, servicing death benefits and helping us with Church drives. He has helped augment Supreme's and Nate Raso's benefits seminars to bring our councils to a 55.8% participation rate, qualifying 19 councils for the Founder's award. I strongly encourage Knights, Parish men and their spouses to participate in future seminars. There are 8 online seminars remaining, so please take 45 minutes from the comfort of your home to learn about the products that KofC membership has to offer.

In the area of programs, the state has been very busy in all facets of the Faith in Action programs. Under Bill McCauley's leadership and mentoring our programs are back on track to pre-Covid levels and have not missed a beat. Between Karl and Bill efforts, state calendars are updated at least monthly with a minimum 3-month outlook to facilitate the planning for the numerous activities within our state.

In the Faith sector, Jerry Hanten has been instrumental in overseeing several key state programs. Jerry organized state level devotionals, processionals, and rosaries to meet the States Faith Formation goal. Key programs such as St Joseph Icon, Silver Rose, and the Chrism Mass were significantly supported this year. We conducted a statewide processional at the St Catherines of Siena (UofU) and a statewide devotional at St John the Baptist (Draper). We asked Joe Ligori (residing in Texas) to chair and reenergize our RSVP program that now has 16 councils and 2 assemblies supporting our 7 seminarians.

Doug Shane took the lead in Community this year. Our biggest achievement was the State Coats for Kids drive this year. Headed by Bob Masse and the generous contributions of our councils, Utah set a record for over \$55,000 in retail contributions and over 1,500 coats were provided to kids in need. From coffees and donuts, Lenten fish fries and blood drives, the Knights delivered quality service to our Parishes and local communities. Activities such as Knights on Bikes, Lagoon Day, Greek Festival, Special Olympics, Fisher House and veterans support and St Pats Parade provided Knight's visibility in our communities to actually "Make a Difference". For youth programs, Steve Gerichs provided key logistical support to the Soccer Challenge, Essay Contest, Poster contest, and Basketball Free Throw.

Ken Grace joined our team mid-year to support Family efforts. James Harris broke the ice by heading up the Diocesan Science Fair in Feb. Many councils have been involved with breakfasts, steak fries and dinners to foster Parish relationships in conjunction with prayer. This continues with a prime example of Lenten fish fries to attract families to Stations. This year, the State established a Family of the Month award to recognize outstanding contributors. Going forward, please remember that these families need not to be knights but members of the parish who are deeply involved in or contributed to a project.

Pat Schmitt has put forth a yeoman's effort to keep our State aware of the numerous Life/Profile activities that occur month to month. From seminars, prayer services, nocturnal adorations, and marches, Pat carries this torch inside him to promote Life Programs to our brotherhood and our Catholic Communities. A key program was Pat's support to the Supreme's new initiative Aid and Support After Pregnancy program. Here, 9 Utah Councils and 1 Assembly have contributed to a Pregnancy Resource Center that has "made a difference" in the lives of these new mothers. At convention, you will learn about the new Lamb of God Maternity Home in Ogden who will be seeking our support in the future.

For compliance, mandatory form submission sits at 100%. Cleanup is warranted for 7 councils who requires their recent semiannual audits. A recent push for the safe environment by Bill McCauley and our councils has moved our compliance rate to 20 of 34 councils. Yet one more report to submit, the SP7 Columbian Award application. I encourage all councils to turn these in early to obtains credit for all the good work you have done this year. In the future, please consider completing Form 10784 (Fraternal Program Report) after activity completion to make your SP7 form submission process easier. Thanks to Karl VanMaren for reminding us on all deliverables and administrative requirements.

The summer is gearing up to be very busy at we look forward to continuing our momentum into next year. Convocation (Jun 5), Corpus Christi Processionals (Jun 8), 4th Deg Exp (Jun 24), Ordination (Jun 30) Eucharistic revival (Jul 7), Golf Tournaments (Jul 29, Sep 14), Lagoon Day (Jul 30) and Carmelite Fair (Sep) are already on the docket. Mt Calvary Masses on Memorial, Independence and Labor Days combined with Icon and Pilgrim rotation support will keep our Faith Formation support goals on track,

In closing, I want to thank my State Team, Frank, Bill Mac, Stephen, Nick, Greg, Karl and Bob for your dedication and untiring support you provided this past year. Without your efforts the State would have not met Supreme objectives. Thanks to my 13 District Deputies who provided sound counsel and mentorship to council leaders. Your leadership and participation in council events motivated councils to towards successes and you made my job as State Deputy a lot easier. Lastly, thank you to my lovely wife Natalie who has stood by my side with me to make this year a great success for all Utah Knights.

#### **MAKE A DIFFERENCE**

Worthy Brother Knights, this has been a busy year for me as State Treasurer and even busier as your Membership Director. As Utah State Treasurer, I have had the honor to get your books in order and make the financials transparent. We closed the account at Wells Fargo and Transferred \$67, 069.59 to our new Bank Account at Mountain America Credit Union. This change was because Well Fargo is a large bank institution and would not allow us to have savings accounts for all the charities we deal with. Mountain America Credit Union will enable us to open individual savings accounts for all our charities at no cost. We have "been cutting the fat" and saving the State Council money where we can save money

and now collect interest on our money. We have also opened Saving CDs to earn as much as 5.25 APY on our money.

Besides saving the state money and rearranging the bank account to be transparent, I have also been busy posting receipts and warrants on Quick Books and sending you checks as needed. Once I received that warrant request, I got the checks out within a two (2) hour window. I have visited 88% of all our councils' promoting programs and membership, showing you the account numbers and promoting my run for State Secretary in 2023-2024. I apologize for those councils I did not get a chance to visit. I have also participated in many of your programs and even helped you in the kitchen at council events. I have lent out my music system for events like Marti Gras, fried fish and French fries, cooked spaghetti, bartended, grilled chicken, and many more memorial moments.

I have also been busy helping our State Deputy with State Secretary duties per his request. I have been chasing down form 1728s, Per-Capita payments, requesting Delegate credentials, learning programs like Cognito, the Delegate checklist on Google Drives, the affiliate program, and fixing the State Secretary ledger as needed. I have also built a strong bond/relationship with Bishop Solis. I have also been asked to take charge of the entertainment for the State Convention, Cinco de Mayo Friday Night, and Casino Nights on Saturday Evening. We created a State Council VENMO account for those who do not want to write a check and waste a stamp, welcoming the Utah State Council into the 21st Century.

As your Membership Director, I have been busting my behind with State Deputy "Wild Bill" Kelly to make The State of Utah one of the top districts in the order. When you read this message, we should be at 100% membership and relaxing, but it has not been easy. Many priests have requested new life in the existing councils, and some have asked for NEW councils at their parish. I am proud to say that Saint Ann's in SLC will have a new council by the end of this year. We have conducted many church drives and CUF Degrees across the State to help grow our order and MAKE A DIFFERENCE in our State. Organizing and executing church drives is not easy, but very satisfying.

We have taken some of the per-capita council's pay and bought you membership materials, which we have personally distributed to all councils in person, by mail, or at our state meetings. We have distributed 15,000 "Why become a Knight" pamphlets in English, Spanish, and Vietnamese. My daughter and I spent hours putting QR Codes on these pamphlets for all of you, one at a time. We have also passed out over 5000 QR Code membership cards. We also bought placemats for your dinner events and fish fries. The best part about those placemats is that they come with a Ray Lopez picture. We have asked Financial Secretaries to join us in the 21st Century, stop using form 100s and stick to the QR Code cards we have distributed.

WFVSM Chuck Dover Jr. challenged me to promote the McGivney Guild as we encourage membership, and I am proud to say I helped him create a QR Code that takes you to the website. We have distributed over 500 McGivney cards at council meetings and functions. We have made Utah the top District in the McGivney Guild, the national average is 18%, and we are over 50% leading our order. Thank you.

Brothers, I can go on and on talking about my ventures as Utah State Treasurer, but who has the time? With the support and blessing of our State Deputy, I am ready to move up to State Secretary, and I ask you for your support. Just as I left the District Master's position I am now prepared to leave the State Treasurer's position just a bit better than I found them, I am ready to tackle the State Secretary position and make the necessary corrections. I thank you for your time, patients, and support. May God Bless you and your families, and May God Bless America.

Our State is young and still growing; please help it grow and advance in the upcoming years.

## William T. McCauley, State Advocate

Brother Knights All,

This year continued to be challenging for many of us, but we stood together as Catholic men, accomplished what Blessed Father McGivney set forth for us and "made a difference". I am honored to serve by your side.

Thankfully, as in the past, the duties of State Advocate are limited due to the Knights of the State of Utah doing what they should be doing. When requested, I arranged for Councils to receive proof of insurance for events and interpretations of by-laws. I was also able to suggest resolutions to update our by-laws. served as advisor for the State Officers on matters that were referred to me, conducted investigations, held discussions with Supreme Advocate and sent my findings to the State Deputy.

The State By-Laws were last changed in 2019. In February, I sent proposed changes to the Grand Knights and others for suggestions and analysis. Based on their response, sixty days before the State Convention, I sent out another letter with all the proposed resolutions that I will present at the State Convention and asked the Councils for their resolutions to be submitted by March 31, as well as final critique of the proposed resolutions. The Resolution Committee met in April and will make their recommendation at the Convention. Every Delegate should have a copy of the Resolutions.

I worked with the Supreme Advocate Office for information on EINs for Councils and Assemblies. Every Council and Assembly in Utah has an EIN. The Supreme Office has the list of EINs and all but one Council and Assembly is covered under the tax-exempt umbrella for the Knights of Columbus (that Council will be covered next year). Every Council and Assembly needs to file each year with the IRS.

Additional duties assigned to me were State Program Director, Safe Environment Compliance Officer, Affiliate/Retention Chairman, and Catholic Citizenship Essay Chairman. All these reports are found elsewhere in this book.

In addition to the formal duties of the office, I have attended Church Drives in American Fork and Salt Lake City, Knighthood and Patriotic Degree Exemplifications around the State, as well as many Council events and meetings. At every turn, I have observed Knights fulfilling the vision of Blessed Michael McGivney that with an Order based on charity, unity and fraternity, ordinary men working together can perform extraordinary deeds of good works for church and community. I am proud to be one of you and honored to serve as your State Advocate.

#### John H. Reddin Province – Utah District

The health of the Patriotic Degree in this District is good. For the Fraternal year 2022-2023, we held three (3) regular Exemplifications that resulted in 40 new members into the Fourth Degree and two (2) special Clergy Exemplifications that resulted in 3 priests and 1 deacon joining the Fourth Degree. In the fraternal year 2022, two (2) exemplifications were held. One in August, hosted by Assembly # 2577 and one in October, hosted by Assembly # 2636. In this year of 2023, an exemplification was held in February, hosted by Assembly # 1144. We have two more exemplifications scheduled for this Fraternal year. One on April 22nd in St George Utah, and one on June 24th in Magna. At the exemplification, we've had a strong attendance of knights in uniform and as witnesses. Knights' appreciation and memorials for recently deceased sir knights and deceased family members, also a flag presentation given to the class honoree.

#### **Honor Guard and Color Corps Activities:**

Training Program – Honor Guard and Color Corps requests continued to increase throughout the state. We now have a District "Warden" Marshal to help the Master with training, to include the new manual of the sword with all sir knights in uniform.

The Patriotic Degree is involved in many projects. Our commitment to the Special Olympics continues. We have a large number of participants in uniform at opening flag ceremonies, several more knights in K of C attire are there to take part in a "high five" upon the entrance of the athletes, and most councils and assemblies offer financial support to the athletes.

We continue to support the Fisher House at the George Whalen VA Hospital and Campus.

Assemblies are involved in parades, memorial presentations, VAVS, and sponsor banquets for Priest Appreciation evening and other events for our Veterans.

Requests for Honor Guard for First Communions are covered to the best of our ability. Confirmations held throughout the Diocese by the Bishop was attended by an Honor Guard. The Honor Guard participated in Masses of the Unborn, Chrism Mass, Pro-Life Masses, 9-11 Day of Remembrance, National Pearl Harbor Remembrance Day, Blue Masses, Deacon Ordination, Scouting Religions Award Ceremonies, Mass for the Disabled, Memorial Day Mass at the Cemetery, and other events throughout the state.



The Patriotic Degree members continue to support their Sir Knights at funeral masses and vigils for our members and their immediate family members. We continue to offer a Resolution of Condolence to the family of our fallen Sir Knights: we have also participated with the US Military in celebrating a fallen knight and current service members. Three Clergy funeral vigil and masses, state meetings including the organization, mid-year and convention masses, Pro-life marches, rosaries and masses, flag day ceremonies throughout the state, parades/festivals (Veterans Day, Draper Days, Taylorsville,

St Patrick's Day and others). The Utah District continues to grow and be involved in many of the patriotic events and parish activities in the state.

Prior to every church event that takes place, the area marshal or I greet the pastor and talk. When the Bishop is the celebrant, we let him know we are here to serve, we are his shining knights.

Bishop Solis is a big supporter of the Knights. He encourages men to become members of the Order and his priests to become Fourth Degree members.

#### **Fourth Degree Exemplification**

With Supreme's guidance, we've been able to do smaller exemplifications without a banquet. By doing so, we have been able to bring in our numbers needed. Change to exemplification with 20 or less Fourth Degree candidates – there is no banquet, we hold a light reception afterwards. Instead of a \$75 fee, the price is \$50. The Fourth Degree Sir Knight still receives everything else (flag, certificate, lapel pin and social baldric). Candidates are asked to arrive dressed in a dark suit or sports coat, white or light color shirt and a tie. Sir Knights need to be in uniform or dressed like the candidates.

#### Laws and Rules Governing the Fourth Degree of the Knights of Columbus

ARTICLE XII COLOR CORPS Section 41:

The Establishment of (a) Assembly may henceforth establish a uniform drill corps with the approval of the Master of the District and such unit shall be known as "Fourth Degree Color Corps of \_\_\_\_\_\_ Assembly". (b) A Color Corps may participate in exemplifications, religious and public functions only with the consent of the Master. The Master shall have full control of the Color Corps in his district, except as hereinafter provided and shall be held strictly accountable for such unit. (c)The Faithful Navigator shall appoint a Commander of the Color Corps for the Assembly. One and only one Commander shall be appointed.

- The District Marshal is a representative of the District Master, and since the District Master shall have full control of the Color Corps in his district so shall the District Marshals.
- Stacey A. Yeager is the District Warden Marshal of the Utah District assist District Master whenever possible district training; all color corps training is to be coordinated through him.
- District Marshals will be in command of all assembly or District Color Corps when they are in attendance in or out of their areas whether the District Master is there or not.
- Color Corp Commanders will take control of the Color Corps when there is NO District Marshal in attendance whether the District Master is in attendance or not.

My intention was to have them finished much earlier. I gave myself deadlines and somehow other tasks would interfere. For 2023, my plan is to have them by the Organizational Meeting in July.

Second, THANK YOU. Thank you for selecting me as Utah's Associate Delegate to the 2022 Supreme Convention in Nashville last August. It was an amazing experience. The first Knight I should thank is Chuck Dover Jr. PSD, since he was the one who suggested to John Wainscott FSD, PSD to nominate me at the convention. He also was an excellent chauffer in Nashville, and made sure we saw the sights and



didn't just "hang around our rooms." We found some interesting places to eat, and some cultural sites to visit (downtown Broadway with the bars, Andrew Jackson's Hermitage, Johnny Cash Museum, and The Parthenon stand out). It was another busy year. As usual, my goal was to be helpful to all my brother Knights. Providing the calendar page to the State Update Newsletter seemed like a simple way to give an overview of the current and upcoming months to help the leaders focus on the current activities and plan for the future.

Speaking of calendars, it was from a conversation at the Organizational Meeting in July that a new submission form was created so councils (and assemblies, or even districts) could share their program/event plans and get them onto the state calendar (and often the state website homepage). I definitely need to thank IPSD Nick Nielson for doing the work of creating the form, and adding the "submit your event" box underneath the sidebar calendar on the state website.

There isn't anything magical about the form at <a href="www.cognitoforms.com/UTKofC/UTKofCActivityForm">www.cognitoforms.com/UTKofC/UTKofCActivityForm</a> -- the main advantage of using it? It has all the questions so important and relevant details aren't overlooked. My least favorite time to hear about for an activity? "After Mass" – not that having plans after Mass is bad, it's just that I don't know when the Mass at your parish is, or how long it takes. The one thing the form does have automated? Sending the information directly to the State Deputy, myself, and the State Public Relations Chair (temporarily PSD Andy Airriess).

As I mentioned at the Midyear Meeting in January, I do play favorites on what I post! Luckily, it's easy to be a favorite! Send me the information! That's really all it takes! I want to share accurate information, so I'm not going to be making things up. Any Knight (or person) can submit the form, just let whomever has all the details do it, no matter if it's the Grand Knight, Financial Secretary, Program Director, Event Chairman, Trustee, Brother Knight, or a relative or friend of one of the above!

The Lenten Dinners this year were challenging to post on the state website, as most of the time it seemed Knights only knew the dates of their Fish Frys, not the serving times, cost, schedule for Mass and/or Stations of the Cross, or even the menu. I listed what I knew, and provided links to the details when they were available. I did get a chuckle out of an Activity Form submission by a brother Knight when he put in his own name as the name of the event. I think that's the first time I've heard of a Fish Fry being named after a living Knight! Yes, it was a simple mistake, and a quick phone call cleared it right up. The same Knight had put in his council's previous Fish Fry correctly, so I thought it best to ask. In the end, there were 20 revisions of the schedule, the final version ("T") was published on March 18<sup>th</sup>.

Another challenge connected to the Fish Frys was ordering recruiting supplies. I personally ordered 11,500 placemats (in 15 separate orders), most of which were the English 1915E, with 1000 in Spanish (1915S). State Deputy Bill Kelly liked having these available to bring to the various dinners he attended. This item did have some interesting pricing and ordering challenges through the weeks. In January, 500 of the English placemats cost \$39.46 (plus \$1.91 tax), and then a price correction was made to make them free. The Spanish stayed at \$25.00 per 500 with \$1.21 tax. After a system update, the Spanish became impossible to order (selecting a single package of 500 results in the message "You have attempted to order 500. The maximum quantity you may order of this item is 2."), and the English ones went out of stock. Apparently having items available for free (with no charge for shipping) increases the popularity, and stock levels were impacted. I've been told the system will be updated to correct the "free" cost on the English ones, and make the Spanish ones available again. Don't worry, assuming the backordered English placemats ship, the State Warden should have a good supply for next year's Fish Frys (and any other activities). Getting 11,500 placemats for a total cost of \$93.79 seems good to me!

This fraternal year I've also ordered 16 church drive kits (English & Spanish), which were on back order most of the time. They eventually did arrive, and the prayer cards were used at church drives all over the state. The lesson from those was twofold: first, pay attention when it says an item is on backorder, and secondly when supplies are on backorder, be prepared to wait for them (sometimes the delay was over a month). When ordering supplies, it's definitely a good idea to plan ahead – and not just the week that ground shipping takes.

The virtual State Officer meetings held each month with the District Deputies, and Program Directors were a great source of information and accomplishments. Hopefully their written reports show the same level of excitement and enthusiasm that was evident at the meetings. Every month we heard from Program Directors and District Deputies that were proud of what was happening in their area.

The suggestion was made to District Master Bob Masse Jr. PSD that perhaps SignUpGenius would be a useful way to collect RSVPs for the various Honor Guards. It actually has been very helpful as anyone (with the particular link) can see who has RSVP'd, and if they're coming (yes, no, or maybe). Visit <a href="https://www.TinyURL.com/UT4th">www.TinyURL.com/UT4th</a> to see the list of upcoming honor guards. Click the title to see the details, and the SignUpGenius.com link should be the first item. The main issue we've had is Knights are hesitant to actually RSVP. It's a simple thing really, it only needs four pieces of information, first name, last name, email address, and the response (yes, no, maybe); the comment is optional (but is useful for Color Corps Commanders or District Marshals to note their position). Hopefully this will be getting more use in the future. George Ortega's funeral on 12/29 was the first one, and since another 33 have been created for various events (vigils and funerals, Diocesan Masses, Confirmations, First Holy Communions, Ordinations, Saint Patrick's Day Parade, Holy Hours, State Convention, etc.).

Another area that needed more attention this year was the training webinars offered by Ken White, a Fraternal Trainer at supreme who started the fraternal year as our "Associate Regional Growth & Training Director, Western Territory" and who provided several virtual training opportunities each month – in addition to offering to travel to us in Utah. I say this needed more attention, not because Ken's offerings were lacking or needed improvement, but because so very few Knights from Utah attended them. To keep them current, they're not recorded. They're presented live each time, and for a while that was twice a night because of the multiple time zones Ken serves. I think I've attended all of the different webinars he has offered, so I can confidently say there is useful information in each one! To view his current schedule on the Supreme Council website, visit <a href="www.TinyURL.com/ARGTDKen">www.TinyURL.com/ARGTDKen</a>. The other Fraternal Trainer for the US is Jon Olson, and his schedule is also posted. I've attended one of his webinars, and while it was a topic I heard from Ken White before, he did have a different approach that some might prefer. Jon was the presenter for the March 9, 2023 supreme webinar "Getting Online Joins Into Your Council" and that one was recorded and is available on demand at <a href="www.kofc.org/en/for-members/resources/webinars/030923.html">www.kofc.org/en/for-members/resources/webinars/030923.html</a>

There certainly were some low points this year. Some of them seemed like they were a long time ago, but when I saw this year's necrology list, I was reminded that the pain was more recent. I miss four Knights in particular from the list. Former State Chaplain Father Blaine was an amazing supporter of the Knights in Utah, and even as his health decreased, he didn't waiver. We just kept praying for his heart and health. Past State Deputy Rholand Lange was one of a kind. I really thought we'd see him at this year's convention after he skipped the one in 2022. His "back in my day" stories defiantly had a different perspective! When the State Council was smaller with fewer districts and councils in Utah, there definitely was a different way of doing things. Sir Knight Ray Bachiller, was another stubborn Knight whose ailing health wasn't widely known. In retrospect, he was in and out of the hospital fairly often, but that's the thing, he would be out and back to work quickly; the short hospital stays never

seemed to cause alarm. Ray had an amazing balance of working behind the scenes most of the time, while also being comfortable in front of a crowd asking for support for two veterans' charities that were dear to him (the SLC Fisher House and APSC). My council lost only a single member to death this year, but I also greatly miss him. Of course, being ABC4's senior crime reporter definitely helped Marcos Ortiz to be known across the state. His death from a sudden heart attack reminds us of our order's perpetual watchword of "Tempus Fugit. Memento Mori." which means "Time flies. Remember death." When you can, please say some prayers for all those on the necrology list; it's the last page of this report compilation.

Hopefully another brother Knight from my council is well on his way to being one of the most well-known Knights in the state. William Mundy is the KofC Field Agent covering the whole state of Utah, so if you haven't met him yet, I'm sure you will soon. He might even invite you to join the Knights of Columbus Assembly 2577 golf tournament coming up on July 29<sup>th</sup> to support the SLC Fisher House and APSC charities. www.UtahKofCgolf.org

It is both an honor and a pleasure for me to address the 116th Annual Meeting of the Utah State Council and I send my sincerest regrets for not being able to attend in person. It has been exciting learning about the excellent programs and watching the faith and dedication of the State Officers, District Deputies and members of Utah being put into action in your Parishes and Communities. I am looking forward to both finishing this Fraternal Year strong and starting off next year in a flourish of activity and growth.

State Conventions are a chance to renew friendships and to develop new fraternal bonds with Brothers from around the State as we join forces to recognize the outstanding programs of the Councils and, through these programs, to cultivate and promote the Knights of Columbus in our Communities, Parishes and Families. These annual meetings allow the State Team and members of the State Council to review the growth and celebrate the successes of the Councils and Districts. Yet even as we celebrate those successes, we must also realize that our year is not over and our work is not done for the year.

As we meet in Convention to celebrate the activities of the year, conduct the necessary business and to plan for an ever-brighter future of Columbianism in Utah, let us also keep foremost in our minds our

#### St. Joseph - Council 777, Ogden

They participated in the Coats for Kids campaign and had a great showing from children at the annual District and State Free throw competitions as well as provide for the good of the community through charitable donations. 602 is a busy well-run council that has been setting their vision on the future and taking the necessary steps to be successful in the short term and the long. The Knights support many activities supporting the congregation at the Cathedral as well as the general community. The council has not submitted the last two semi-annual audits as of Mar. 31, 2023.

12264: The pandemic has hit this community hard and is still casting a long shadow over the inperson social activities of the parish. Activities have returned to St Pat's, but the parish is still struggling to regain the sense of community lost to an earthquake and a global pandemic.

Council 12264 is a small but dedicated group of men doing their best to support their parish and community. The council supports their priest, Deacon, parishioners, and families. Council meetings always begin with a rosary. The prayers are dedicated to a specific need. At each decade, an additional focus for the prayers is often added. The rosary is said in English and sometimes in Spanish and is followed by the Litany of the Virgin Mary and the Prayer to St. Michael the Archangel. This is always the best 30 minutes of my week. The few men at the meeting will do the business of the council: donating money to help a parishioner, develop and execute a raffle to raise money for the church, support weekly Bingo, and provide the Ash Wednesday Fish Fry. This is all to provide the Parish Paster the support he needs. It is common to schedule a service activity while holding the monthly Council meeting; cleaning the parking lot, cleaning church windows, assembling awnings for an upcoming Parish activity, or any one of several necessary though not very glamorous activities.

It is really clear that Council 12264 is a service organization. In that vein, be sure to look for the Council 12264 ad in the convention program where their ad includes a request for financial support to reconstruct the parish building destroyed by the earthquake. Between the raffles, fish fry, and parish support, the Knights of 12264 have carried a big load. They are to be commended as a strong group of men who, when the Lord asked 'Whom shall I send?' reply "Here I am; send me." (Isaiah 6:8)

I am most proud of the financial results of this small council. And supported a Seminarian financially and with letters of encouragement.

#### St. Martin de Porres Council 10304, Taylorsville

Some of the noteworthy activities the council has been able to accomplish

- Two council members each donated 3 hours weekly to serve at the St. Vincent de Paul Soup Kitchen. This was for all 4 weeks of January 2023.
- BINGO every Tuesday, for 3 hrs. averaging \$1700 weekly after expenses. All money raised goes to the parish needs. Council members help out at the Parish BINGO every Tuesday night.
- A Council member and his son spent two 4-hour shifts sorting and arranging donations at the Re-Store for Habitat for Humanity. The store sells donations received to support the building of Habitat homes in the local area.

- A Council family worked for 20 years donating prizes for raffles at their own expense. Most recently over \$400 in proceeds were given to the council to be used for seminarian support & religious education. They continue to promote Blessed Michael McGivney's vision. The family is involved with parish life and at present support many church programs. The most recent involvement is a testament to their commitment.

#### St. Thomas More Council 11479, Cottonwood Heights

The Knights at St. Thomas More Parish and Council #11479 are becoming fully reengaged as a functioning Council in support of the needs of our Parish and broader community. The service activities of the Council were many and varied! In addition to meeting our monetary obligations to the KofC State programs, we engaged in the following service activities:

**Faith Formation** – Knights of Council #11479 meet weekly in a Faith Formation Bible Study. This is well attended by many of our active Knights each Friday morning at 7:30 am.

**Garage Sale** – Council 11479 came together to hold our seventh annual Garage Sale in August. Approximately 12-15 Knights worked together to coordinate the collection and organization of donated items. Drop offs were scheduled both in the mornings and afternoons for the week prior to the Saturday event. We received approximately \$5,800 in receipts that the Council was able to add to our checking account. This will help us to meet our financial obligations to both the State and local parish service obligations and other operational expenses.

**Book Sale** – This past November we were able to hold our annual Book Sale. Council Knights coordinated the set-up of bookshelves and tables to display donated books by our parish faithful. All of the receipts from the book sale were treated as cash donations. Approximately 15 Council Knights came together to coordinate the event. We were able to raise \$780 from this event.

Ladies Boutique – Our Ladies of STM annually hold a boutique and luncheon at the beginning of December. This is typically a very large event in which our Council becomes very involved in the set-up, tear-down and the service support for this event. The Knights of our Council helped with covering the gymnasium floor with protective carpet and cardboard as well as its removal after the event.

**Fish Fry** – Council #11479 support all aspects of an annual Fish Fry during the Fridays of Lent. Approximately 15 Knights coordinate the kitchen and cooking preparation, bar set-up and sales as well as the cash coordination to hold this parish wide event.

**Blood Drive** – Council Knight Bob Schaovars coordinated this annual blood drive event at the Parish. We were able to create a very successful contribution of blood at a time of donation shortages across the State.

Carmelite Fair – Many of our Council Knights work tirelessly with the organization committee to put on a successful event to support the finances of the Sisters of the Carmel of the Immaculate Heart of Mary in Holladay Utah. This year, Michael Griffin supported the coordination of donations for the drawing of a Kia Sportage. This car was donated by the Jerry Seiner Group and is the main source of revenue to the Sisters from the Fair. Other Knights support the grounds layout, coordination of volunteers for the setup and tear down of the event. Together as a council, we donate hundreds of hours of volunteers support to make this event successful.

**Carmelite Thanksgiving** – Annually as a Council, we support and underwrite the annual tradition of providing the Sisters of the Carmel of the Immaculate Heart of Mary with all of the food for their Thanksgiving Day celebration. We also make sizeable donations to the pantry which helps them to create the candies and fudges which they offer for sale during the holiday season.

**Fisher House Golf Tournament** – Ray Bachiller dedicated his life in support of the Fisher House. This service non-profit provides free housing to family members of veterans that are receiving medical treatment at the VA Medical Center. Larry Page picked up Ray's torch to helped organize and coordinate the Golf Tournament with other State of Utah Knights to provide a donation to the SLC Fisher House facility and APSC.

Mass Support – Our active brothers also support the parish with parish ministries that allow the parish to operate smoothly. These include music ministries, lectors, eucharistic ministers, ushers, Parish Council members, and Finance Council members.

**KofC Utah State Organizational Meeting** – The State organization meeting was held at STM parish this year. Our Council helped to set up the meeting rooms, coordinate lunch and refreshments.

**Pancake Breakfast** – To foster unity and to bring attention to our Council, we hold an annual Pancake Breakfast after all of the weekend Masses for a specific week. We do all the cooking, food distribution, set-up and tear-down for this event. We do take donation but do not charge specifically for the event and all are welcome.

**Parishioner Relocation** – Tom Buhle, a STM parishioner contacted our Parish Office and requested support in moving from his apartment to another location. Approximately 6 Council Knights pitched in with pick-up trucks, trailer and hand carts to help this parishioner in need.

**Diocesan Dinner** – The Catholic Diocese of SLC requested the STM Meyer Hall and kitchen in support of a dinner to honor major donors to the Diocese. Our Council helped support the set-up and tear-down and well as provided bar service for the evening.

**Science Fair Support** – In support of our Catholic Educators, our Council supported the judging of this annual event.

**Covid Sanitation Procedure** – Our Councilmen come from all backgrounds and possess a wide range of talents and skills. Dr. Palmer Masumbe-Netongo lead a small team to assess the necessary sanitation procedures for the STM church Masses and created the system that was installed and still is used to make sure that we minimize the risks of the transfer of infectious disease among our active parishioners.

St. Rose of Lima, had another very impactful year in all our program areas and our relationship with our new Pastor, Father Gustavo Vidal, continues to grow as well as our council.

**Faith:** This program area has seen strong growth as our Faith Director, SK Joe Garcia, finds paths to strengthen our personal, council and parish commitment to prayer, reflection and spiritual growth. Our council hosts twice-a-month Rosaries which regularly draw 10-20 faithful. We've embraced the 33 Day Consecration to St. Joseph as a retreat with daily readings and rosaries and hosted a St. Joseph Icon on the March 19th Feast of St. Joseph at the parish.

**Family:** This year has seen a further strengthening of our work with the Utah Food Bank distributions at Layton Hills Baptist church and the work of City Hope at Nations for Christ church in Clearfield. These "food for families" efforts reach more than 300 families each month. We've collaborated with the Hill AFB commissary to pick up and distribute thousands of pounds of food items in conjunction with the District 10 councils.

Community: Our Coats for Kids program highlights our outreach to the community. Our Community Director, SK Dennis Martinez, coordinated with Davis Schools to get the word out to the broader community and we held two distributions, one at our parish and another at Nations for Christ church delivering more than 400 coats to those in need. Our regular monthly breakfasts, Donuts and Bingo events as well as Lenten Fish Fry dinners provide much needed fellowship opportunities for our parish members.

**Life:** Our Life Director, SK Jim Sorely, coordinated our council efforts for the Novena for Life, Mother's Day to Father's Day donations for Life boxes and the Silver Rose program. Our council financially and in-person supports Special Olympics annually.

<u>Bishop Joseph L. Federal Council 14399, Holy Family, South Ogden:</u> GK Mike Dannenmueller; FS John Tekverk

We are developing a great working relationship with our new Pastoral Administrator, Father Minuth. As a council we are recruiting new members regularly, and as a result we only need one more recruit to achieve our quota for the fraternal year.

We participated in the Food for Families program begun in 2016 by the Knights of Council 16127 for part of the year. During that time, we distributed over 2,000 lbs. of food donations from the Hill AFB Commissary. These donations were donated to Catholic Community Services.

Our Coats for Kids program sent winter coats to Catholic Community Services as well as to several Northern Utah schools.

We sponsored two teams in the "Give Me a Chance" ministry's golf tournament. This helped us to donate \$600.00 to the ministry and gave us the opportunity to golf with Bishop Solis. Our donation of another \$2,000.00 sponsored two tables at the "Give Me a Chance" garden dinner.

Our youth participated in the Knights of Columbus Free Throw Contest and four of them will be participating in the State contest.

Our Pastor, Fr. Max Omana, retired in 2022 and we are learning the ways of a new Military Pastor Father Captain Aaron Ferris. Our council provides a group of Knights who are extremely active in our Catholic Community.

Faith in Action is the program model of the Knights of Columbus. This model offers a mission driven platform designed to consider the needs of men and their families in the twenty-first century.

Knights of Columbus members, parishes and families have the opportunity to make a meaningful difference through the 32 Faith in Action programs. Organized into the Faith, Family, Community and Life categories, the Faith in Action program model empowers Knights to come together to share their Catholic faith, celebrate fraternity with loved ones, and do what they do best — stand shoulder to shoulder in service to the community and to defend life at all stages and in every condition.

One way we have to track programs that our Councils offer throughout the year is by submitting the Fraternal Program Report Form (#10784). This is a great mechanism for Councils to help track their performance in offering faith-filled programs in each of the four Faith in Action program categories.

In order for your council to earn the Columbian Award, it must:

- Complete at least four program credits in each of the Faith in Action categories of Faith, Family, Community and Life
- Complete the Columbian Award Application (#SP-7) due by June 30, submit by June 15<sup>th</sup>
- Submit the Service Program Personnel Report (#365) due by July 1, *submit online*

Through March, only 18 Councils have reported a total of 176 activities.

### Life Director: SK Patrick Schmitt

In the world of Life issues, this past fraternal year has been interesting, challenging, disturbing, and historic. Last year we followed very closely the US Supreme Court case known as the Dobbs V Jackson Women's Health Organization. This was the case that had the potential for a historic outcome, namely, it could overturn the 50-year-old Roe v Wade decision.

This case was wrought with intrigue and analysis from all sides. Would the court do the unheard of and overturn a previous Court decision? Oral arguments were heard on December 1, 2021, with an expected ruling sometime the following June.

Supreme Court Justices were threatened, (including at their own homes), protests for and against were held, and pundits weighed in. A month before the final decision was to be released a draft decision was leaked. This too was something unheard of. To this day, the source of that leak has not been identified.

In the end, on June 24<sup>th</sup>, 2022, the final decision was released. In short, Roe was to be no more. Fifty years of tireless efforts on the part of numerous pro-life advocates had finally paid off. However, this case did not put an end to abortion in America, it simply returned the issue back to the states.

In Utah, a trigger law was already in place. In the event Roe was ever overturned, abortion would immediately become illegal in the state. Within 24 hours of the Supreme Court decision, the Utah legislature certified the trigger law. Abortion was now illegal in Utah – at least it was for about 24 hours. Planned Parenthood sued the state claiming the trigger law was unconstitutional. A liberal judge sided with Planned Parenthood and the case, as of this writing on March 27, 2023, is still tied up in court. A hearing is expected sometime in September of 2023. In the meantime, it is business as usual on the abortion front here in Utah.

As expected, there was an outcry around the country over the Court's decision. Protests took place. Groups such as Ruth Sent Us and Jane's Revenge threatened and targeted individuals, Pregnancy Resource Centers, and churches – primarily Catholic churches. Many were vandalized – including here in

Utah. Between May 2020 and January 2023, the organization CatholicVote tracked over 260 attacks on Catholic Churches alone.

As we await the outcoming of the trigger law case, efforts to protect life have continued here in Utah. In early March 2023, the Utah legislature passed, and Governor Cox signed into law, HB467. This bill

- Protects an unborn child 18 weeks or older gestational age from abortion based on rape or incest in most cases.
- Abolishes all non-hospital abortion clinics in the state of Utah as of January 1, 2024
- All current permits for abortion clinics will not be renewed.
- In all sections invoking the health of the mother, the scope is limited to physical danger or impairments.

Again, Planned Parenthood is not rolling over. In addition to challenging the law, they have purchased land in West Wendover, Nevada, just over the Utah state line. They are currently in the process of seeking approval from the City Council there to build an abortion clinic.

They will not stop, and neither can we.

As we move forward, the battle for Life will not abate any time soon. If anything, it is only intensifying to a level I don't think anyone would have ever dreamed of. We have states literally proposing and passing infanticide laws and an administration currently occupying the White House who are obsessed with this issue and want abortion, without restrictions or limits, codified into national law. In the UK, individuals are being arrested for simply praying silently, in their own heads while standing outside a clinic. Where will this end? A people who are willing to sacrifice its children on the altar of death is a people who are in the ultimate throes of darkness and evil and they are a people who will not last for long.

**ASAP** - On a more positive note, in expectation of the overturning of Roe and knowing the increased need that Pregnancy Resource Centers (PRCs) and other pregnancy organizations would have in supporting women who chose to keep their babies, the Knights Supreme Council initiated a new program called ASAP (Aid and Support After Pregnancy). For every \$500 donation (up to \$2,000) a Council or Assembly makes to a qualified organization, the Supreme Council will contribute another \$100. Councils around the country have embraced this program, including here in Utah.

As of this writing, I am pleased to announce that we have at least eight Councils that have made donations to local PRCs around the state, to Pro Life Utah, and to the new Lamb of God Maternity home in North Salt Lake. Some of those Councils have made more than one donation and several other Councils are in the process of fundraising in order to make donations. I want to personally thank my Brother Knights who have participated in and contributed to this worthy program. **Program Ideas** - Whether it is sidewalk advocacy work such as 40 Days for Life or a Life Chain or simply doing a Novena for Life, a Baby Bottle or diaper drive for your local PRC or one of the many other programs, I encourage you to stay in the fight, stay informed and do what you can to help.

**Your contributions matter!** - To give you an idea of the significance of your work, a couple of years ago the Utah Knights raised more than \$25,000 to fund a mobile ultra-sound machine for a new van that Pro-Life Utah had just purchased. Several times a week this mobile clinic is parked outside of a Planned Parenthood Clinic in Salt Lake or other areas. Statistics show that a woman who sees her baby via an

ultrasound has an 80% or greater chance of keeping that baby rather than having an abortion. In 2022 the Pro Life Utah mobile clinic and Pro Life Utah staff

- Saved 54 babies.
- Served 59 women through the life grant program.
- Performed 449 mobile ultrasound clinic hours.
- Gave 18 baby showers for new mothers.
- Handed out 1200 gift bags and provided direct help to women going into abortion clinics

**Special Olympics** - In addition to all of the pro-life work that we do, there are several other great Life programs to become involved with. Special Olympics is one of those. For many years, Brother David Matyjasik has done a terrific job chairing this program for our Utah Knights. With COVID restrictions lifted, Special Olympics Utah is returning to its regular schedule of events. From polar plunges, and bowling events to Summer and Fall games there are many ways and opportunities to get involved with Special Olympics Utah. The Knights were there at the founding of Special Olympics, let's continue that great tradition. In addition to monetary donations, consider organizing a group of Council volunteers to help out at an upcoming event. ### Ceremonials Director: SK Karl A. VanMaren

#### Worthy Sirs,

This fraternal year we have definitely had an increase of in-person ceremonials of Charity, Unity and Fraternity (CUF). This has both been for new members joining our fraternal brotherhood and for existing members to advance to the third degree. To help familiarize more council leaders with the newer ceremonial, the state council hosted an exemplification the afternoon of July 16<sup>th</sup>, following the Organizational Meeting. It was mainly the District Deputies who were the witnesses, but the message must have gone out to the councils as more ceremonial were scheduled. I attended the ones I could, and while there was usually room for improvement, the ceremonials were conducted effectively. Check the online calendar for upcoming ceremonials; the District Deputies add them as they're scheduled.

One of the recent highlights this year was the CUF at Blessed Sacrament, when Council 6966 welcomed their new pastor into the Knights on February 26<sup>th</sup>. There were over 35 observers in attendance; and from what I saw, every man in the room was a Knight. The council scheduled the CUF following a membership drive that saw two other parishioners join online and participate in the ceremonial.

The process for a prospective member to join the council hasn't changed. It's still done in four (4) parts, and the Exemplification of Charity, Unity and Fraternity is still a major part of it. Just remember your ABC's.

- A Acceptance by the council. The council needs to vote on new members. This can be done via email, or using a website, or at your virtual or in-person council meeting. If they're an online member, information about the Knight is available there, otherwise a Form 100 has the prospect's details. The members should vote on Knights who want to transfer into their council.
- **B Bring the candidate to the ceremonial.** Again, there are options. They can register online for the virtual ceremonial hosted by the supreme council (available on-demand 24x7). If it's possible for the

council to host it in person, that's certainly preferable. Either way this is where they sign the constitutional roll and should receive a rosary, their KofC pin, and hopefully a copy of "These Men They Call Knights" booklet. Dues (if any) need to be paid at this stage (for live ceremonials). It's actually easier if they join online first (possibly with free membership). The ceremonial video is on the supreme council's website for anyone to view on demand, but the *candidate needs to register* for the online presentation to virtually sign the constitutional roll – it's all about intent (and paperwork). A new Knight, or an online member registering and "attending" the virtual ceremonial on-demand at Supreme, will be sent a welcome packet from Supreme (including their rosary, pin, booklet, welcome letter and a prayer card or two). Sending the invitation PDF is the easiest way to share the proper registration link.

- **C Complete the paperwork.** Supreme won't know that you have a new member unless you specifically tell them. They can't automatically know that you council voted to accept the new member. Traditionally the paperwork was done using the "Form 100", now with online members transferring in using the "Prospect Tab" and with the "Candidate Tab" in Officers Online, the paper application "Form 100" has become less critical. It is still the simple option for collecting all the necessary information for transfers on the Candidate Tab. Completing this step also confirms back that the candidate participated in the ceremonial (live or online). Financial Secretaries should also add the ceremonial date for the new Knight's second and third degrees (the CUF is a combined ceremonial, but the dates are recorded separately).
- **D Dues!** It's highly recommended to have the new members join online and then transfer into the council (after the council vote & the new ceremonial). Usually when people enter their own information online, they get it right. Definitely helpful for accurate council records. Free dues may still be available in the future, the promotional code is on the website at <a href="https://www.kofc.org/JoinUs">www.kofc.org/JoinUs</a>. (Or pay the \$30 to join.)

Thank you to the councils (and districts) that have been conducting the ceremonials live (English and Spanish). It's a great opportunity for the new Knights and the existing council members to meet. Remember, the new ceremonial is simpler. The presenters don't need to memorize all the words, just be able to deliver them in an effective manner. The script is available publicly from the website at <a href="https://www.KofC.org/ceremonials">www.KofC.org/ceremonials</a> as are the video recordings. Everything is in English, Spanish and French.

We have two "Ceremonial Kits" to loan out if you don't have all the supplies (i.e., ceremonial baldrics, crucifix, cable and fibers). Councils should provide their own rosaries and pins; a small emergency supply is in each kit. The Ceremonials Director (that's me) has one kit, the other is with State Warden.

# Coats for Kids Chairman: SK Robert Masse Jr.

To start, I would like to thank the State Deputy Bill Kelly, all the state officers, and Karl Van Maren, plus all the councils that pledged and paid the said pledges. From the bottom of my heart, thank you so much. The Coats for Kids program for 2022 exceeded all expectations. This year's pledges and donations were the largest ever.

The Utah State Council proposed to co-host with the local councils a coats for kids event. Proposed distribution was setup throughout the months of November and December, going into January if necessary. In Utah we need to start distribution before "Black Friday" because of our winter.

After contacting our councils throughout the state, 5 areas were found to have the greatest need. The State council is seeking to support local council activities through coats for kids. This will have an immediate and long-term effect on these communities and councils. Utah State council with the assistance from over 22 councils and several assemblies, purchased over 130 cases of coats. With the

generosity of Knights of Columbus Supreme Council that doubled to be 260 cases of coats. We ran out of our initial order of coats and ordered an additional 10 cases (plus 10 cases from Supreme).

Utah Knights of Columbus' goal was to put a warm coat on every kid that wanted one. We were able to include some adult coats as well. Throughout Utah – from Southern Utah to Northern Utah, Eastern Utah to Western Utah, we distributed over 4500 coats, including at the VA and the Indian Reservation.



Every few years, the Knights of Columbus selects an icon of a saint whose patronage is particularly inspiring to Knights and their communities. Each jurisdiction receives one or several of these icons which travel from council to council and serve as the centerpieces for prayer services in parishes throughout the Order. Since the first traveling pilgrim icon of Our Lady of Guadalupe in 1979, more than 174,800 council and parish prayer services with some 22 million participants have been held.

Devotion to St. Joseph was understandably slow to develop in the history of the Church. The "just man," whom God chose to protect, defend and raise the most precious of his gifts to humanity had not a word of his recorded in Scripture. Tradition tells us that our Lord's foster father died — likely with Jesus and Mary at his side — even prior to Jesus beginning his public ministry. St. Joseph carried out his mission of raising, guarding and preparing Christ quietly, courageously and faithfully. For that faithful work, St. Joseph was rewarded — not with seeing the fruits of his labor in this life, but with the incomparable prize of glory in heaven.

Spread devotion to St. Joseph and pray for the courage to stand up and carry out our mission of protecting, defending, and raising future generations. Councils in Utah have taken up the challenge to sponsor prayer services for the second year since receiving our two Icons last year to spread devotion to St Joseph. - The Knights of Columbus has no higher priority than the safety and well-being of the young people served through its programs and activities.
- The Knights of Columbus Safe Environment Program is designed to protect young People served through Knights of Columbus programs and activities from all forms of abuse.
- Councils participating in official Supreme Council programs and activities are required to comply with all policies and procedures of the Knights of Columbus Safe Environment Program.
- At a minimum, the Grand Knight and the Council Program, Community, and Family Directors are required to take the Safe Environment training. The Community and Family Director must also take the background check.
- The training is good for three years, but if personnel changes with the new fraternal year, then those Knights must be trained.

I wish to thank the District Deputies, Grand Knights, and Council Faith in Action Directors for volunteering their time to take the training this year. We still have two months left; some Knights still need training or will need re-training before June 30, but I greatly appreciate the effort of so many of you through the first nine months of the year. As of March 31, 125 of the 142 required Safe Environment positions are either compliant or pending. 24 of our Councils are listed as Compliant in Supreme reports.

Who are the Knights in your council? Lots of council officers complain that "only x numbers of Knights are active in the council." Or "Only x number of members attend our meetings."

Who are the Inactive Knights? Are they Knights who haven't been active for any number of reasons? Health reasons? The health of relatives? Are they working multiple jobs and don't have time? Young family members can eat up a member's time too. These Knights might need help rather than offering help. Reach out to them, find out what the council can do for them.

I personally know a Knight who was totally inactive for his first 20 years of being as Knight. Totally. No activities, no meetings. All he did was pay dues. When the kids grew up and left home, he started and didn't stop. After becoming State Deputy, he became Supreme Warden. What about his dues? Half of a Knight's dues go to the council's coffers, and some are used for charity. So, an inactive Knight is at least helping the council pay for operational expenses and helping support charity. That's not so bad, is it?

Are Knights who are not active personally invited to participate in activities? People like to feel needed. Ask them man-to-man.

Knights who don't come to meetings are a different matter. Why don't they come? Are your meetings too long and unorganized? One Utah Grand Knight I know had 35-minute meetings and everything got done. He started with pizza and had a social session with refreshments after the meetings and there was no shortage of members attending. Are your non-attending members individually invited to the meetings? Do they even know when the meetings are? Are you giving everyone sufficient notice for the meetings when reminding by email or phone (3-5 days before rather than the day before). To get Knights to regularly attend meetings it must become a habit. Keep the changes made to ensure your meetings are more attractive in place for 9-10 months before trying something different.

Are you distributing minutes of your meetings to all members after they are held? If member can see that actual business is done and programs in place, and faith-filled moments are included, like prayers for those in need, that might attract a few to attend.

The most valuable Knights are those who are active, but Knights who are less or not active can be helpful too, even if it is just paying dues. Every Knight is valuable in their own way, acknowledge them as such by respecting their time, inviting them grow in their activity, and giving them reasons cherish their Knighthood and watch your council, and the charity it provides, flourish.
