Gathered in Washington, D.C., for the 143rd Supreme Convention of the Knights of Columbus, we convey our deep gratitude and filial devotion on behalf of our more than 2.1 million members worldwide. The Order's recent assistance in restoring Bernini's iconic baldacchino and Chair of St. Peter in St. Peter's Basilica, as well as the Chapel of the Sacred Heart at the Church of the Gesù, is itself a "tangible sign" of our devotion and our commitment to the Church's unity and mission of evangelization.

Holy Father, we pledge our unwavering loyalty and prayers for your apostolic ministry, especially as you call the Church to unity and renewed missionary zeal. 

Thank you, Doug Shane, for compiling and completing the packet while I was away at the Supreme Convention. Welcome GK Pat Trim, DGK Bob Meierdierks, FS Pat Garcia to the team. Welcome to the Brothers of the new council. Now we can work to recruit even more new members to be CHARTER Members of this newest Council!!

Also, this past week, we had the 2025-2026 State Directory published. We will be getting these out to your District Deputies and Marshals the week after Labor Day for distribution and use. We understand that there may be errors in it, just let Doug or I know, and we will update our electronic directory and the State web page accordingly. Thanks to all of you who timely responded to our requests for information so we could attempt to get you a good product early in the year for immediate use.

Thanks to 25 councils and the 3 assembly who have submitted their 25-26 Per Capita payments. The state sincerely appreciates your timeliness in these payments as it enables us to effectively manage the state budget without having to figure out where wot pull funds from to cover upcoming projects.

Regarding administrative requirements, we are doing well. Officer reports stand at 100%, Program Reports need only 2 submissions, and for DD 944 reports only 3 outstanding. However, we do need some work on Semiannual audits for the period 1Jan-30Jun25, here we have 9 councils who have not submitted. Applicable councils, please get this done. I realize several of you are behind on this, but if you just submit the current report, you will be all caught up. Why is this important? Timely submission bonds your financial secretary in the event something unfortunate happens. If you need help on completing this form, reach out to your DD or to Doug or I and we will help you.

Another area, I need your help on is safe environment. I realize that I am a broken record on this subject but it is important.

Please have your GKs and Program Directors complete the training and submit the background investigation form as soon as possible. If it is not completed by Oct 1, Supreme Safe Environment Department will remove your appointees creating more work for you. Please ask Steve Gerichs for assistance in this matter. Significant upcoming activities that should be on your radar include: submitting your Coats for Kids orders/pledges to Bob Masse - now, 4deg Provincial meeting on 20Sep, Carmelite Fair on 21Sep, the relics at St Joseph the Worker on 26-28Sep.

Thank you for all that you do and your continued support to the State council.

Faith Director The month of September is dedicated to Our Lady of Sorrows, whose memorial

the Church celebrates on September 15. September falls during the liturgical season known as Ordinary Time, which is represented by the liturgical color green. This symbol of hope is the color of the sprouting seed and arouses in the faithful the hope of reaping the eternal harvest of heaven, especially the hope of a glorious resurrection.

"The purpose of the Devotion of the Seven Sorrows is to promote union with the sufferings of Christ through union with the special suffering that Our Lady endured because she was the Mother of God. By uniting ourselves with both the Passion of Christ and His holy Mother, we enter into Jesus' Heart and honor Him greatly; He is more honored because we have so honored His Mother.

The Seven Dolors are taken from Scripture events and the devotion has a long history, although it was not officially promulgated by the Church until the early nineteenth century. Before Pope Pius VII's formal approval, the Servite Order had permission in 1668 to celebrate the Feast of the Seven Dolors because the Order was instrumental in popularizing the Seven Sorrows Devotion."

Why the Knights offer Disability Insurance

Disability insurance is essential because it provides a safety net for individuals who are unable to work due to illness or injury.

According to the Social Security Administration, about 1 in 4 of today's 20-year-olds will become disabled before reaching retirement age.

This underscores the likelihood that many workers may face a long-term disability that could prevent them from earning an income. Without disability insurance, these individuals would be at risk of financial hardship, struggling to cover everyday expenses like rent, utilities, and healthcare.

In fact, nearly 40% of Americans report that they would have trouble meeting their financial obligations within a month if they lost their income, highlighting the importance of income protection during times of incapacity.

Additionally, disability insurance helps maintain financial stability and quality of life during periods of disability, which can be particularly important as medical costs can skyrocket.

A report by the Council for Disability Awareness states that over 90% of disabilities are caused by illnesses, such as cancer, heart disease, and mental health conditions, rather than workplace accidents, meaning they can be long-term and unpredictable. Having disability insurance allows individuals to focus on recovery without the added stress of financial strain.

Moreover, the average long-term disability claim lasts 34.6 months, demonstrating that a short-term solution, like savings, may not be enough to cover living expenses over a longer period.
